RE: INSTITUTIONAL GENERAL EDUCATION COURSE OFFERINGS

As discussed with the Board at its December 7, 2023 regular meeting, given the recent adoption by the State Board of Education of Rule 6A-14.0303, which implements new statutory requirements (ss. 1007.24, 1007.25 and 1007.55, F.S.) enacted during the 2023 legislative session, each Florida College System institution board of trustees and president must annually review and approve, at a public meeting, the courses offered by the institution that meet general education course requirements.

The Board has recommended that the College observe certain principles in its review of institutional general education courses, in developing recommendations for the Board's review and approval:

- Reduce the number of institutional general education courses offered, with particular attention on current Valencia institutional general education courses that are offered by fewer than 10 other Florida College System institutions/State Universities.
- Ensure that Valencia's institutional general education course offerings reflect the broad, survey nature of general education, avoiding niche or boutique courses, with a focus on preparing students for success in the workforce and in baccalaureate programs.
- Ensure that Valencia's institutional general education course offerings meet the course standards outlined in 1007.25 F.S. and other requirements outlined in applicable law.
- Consider courses that most other FCS/SUS institutions offer in the review and updating of Valencia's institutional general education course offerings.

Twenty eight (28) institutional general education courses are recommended for approval, representing a 44% reduction in the number of institutional general education course options as currently offered by the College; and 96% of the recommended institutional general education courses (27 of 28) are also offered at 10 or more Florida College System institutions/State Universities.

RECOMMENDED ACTION:

The President recommends that the District Board of Trustees of Valencia College approve the institutional general education courses as recommended and presented, for submission to the State Articulation Coordinating Committee, leading to final consideration and approval of the State Board of Education.

SB266: General Education

May 9, 2024









VALENCIACOLLEGE

The Legislature finds it necessary to ensure that every undergraduate student of a Florida public postsecondary educational institution graduates as an informed citizen through participation in rigorous general education courses that promote and preserve the constitutional republic through traditional, historically accurate, and high-quality coursework. General education courses should provide broad foundational knowledge to help students develop intellectual skills and habits that enable them to become more effective and lifelong learners. Courses with a curriculum based on unproven, speculative, or exploratory content are best suited as elective or specific program prerequisite credit, not general education credit. General education courses must:

1007.55 F.S. (continued)

- (a) Meet the course standards as provided in s. 1007.25; and
- (b) Whenever applicable, provide instruction on the historical background and philosophical foundation of Western civilization and this nation's historical documents, such as the Declaration of Independence, the United States Constitution, the Bill of Rights and subsequent amendments, and the Federalist Papers.
- (2) Public postsecondary educational institution boards of trustees and presidents are responsible for annually reviewing and approving, at a public meeting, general education course requirements, as authorized and approved in accordance with ss. 1007.24 and 1007.25 and this section, at their respective institutions.

(a) Each Florida College System institution board of trustees and president must annually review and approve, at a public meeting, the courses offered by the institution that meet general education course requirements in accordance with ss. 1007.24, 1007.25 and 1007.55, F.S.

The following must be included for each listed general education course:

- (a) The general education distribution area;
- (b) The number of state universities that offer the course and the number of Florida College System institutions that offer the course; and
- (c) The course level.

(b) Each institution must submit its approved list of general education courses to the Articulation Coordinating Committee no later than September 1 of each year by the course prefix and number in the Statewide Course Numbering System, including the institution's course title, the general education distribution area, the course level, and the number of public postsecondary institutions that offer the course in a format prescribed by the Department.

Summary of December 7, 2023, Board Discussion

The Board recommended that the College, in its review of its general education courses in preparation for the Board's review and approval at its May 2024 meeting:

- Reduce the number of institutional general education courses offered, with particular emphasis on the courses that are offered by fewer than 10 FCS/SUS institutions.
- 2. Ensure that Valencia's institutional general education course offerings reflect the broad, survey nature of general education, avoiding niche or boutique courses, with a focus on preparing students for success in the workforce and in baccalaureate programs.
- 3. Ensure that Valencia's institutional general education course offerings meet the course standards outlined in 1007.25 F.S. and other requirements outlined in 1007.25 F.S. and 1007.55 F.S.
- 4. Consider courses that most other FCS/SUS institutions offer in the review and updating of Valencia's institutional general education course offerings.

Work Completed To-Date

An Ad Hoc committee – a subset of our College Curriculum Committee (CCC)

- ✓ met every Friday in the Spring 2024 semester (total of 10 meetings/~20 hours)
- ✓ reviewed data on the Gen Ed courses offered at FCS and SUS institutions
- ✓ facilitated additional discipline-specific faculty and dean meetings
- ✓ developed draft recommendations for review by Senior Team and college leaders & revised based on feedback
- ✓ presented list of recommended courses to CCC

Drs. Plinske and Artze-Vega examined the alignment among the recommendations and the criteria, accepting all but one of the proposed courses (28 of the 29).
