CREDIT COURSE ADDITIONS

CRW 2001H Creative Writing/Advanced Comp Honors, CCA........R. Tullis

Purpose: This course will allow honors students to attempt CRW 2001 while also receiving honors credit; **Credit/Contact/Lab Hours:** 3/3/0; **Prerequisites:** ENC 1101 or ENC 1101H or IDH 1110; **Corequisites:** None; **Course Description:** An interactive writing course in which students develop creative writing skills in selected literary genres--short stories, poetry, plays, novels, personal essays or magazine articles--with additional honors content and outcomes; **Effective Date:** Summer 2024 (202430).

NUR 2804C Professional Nursing and Health Concepts II, CCA......R. Alvarez

Purpose: Curriculum was changed to allow only one pathway but added an extra semester to increase student success. The course was previously approved under a different course number. Need new course number to circumvent confusion for students registering under old curriculum pathway; **Credit/Contact/Lab Hours:** 6/14/4; **Prerequisites:** Admission to Nursing A.S. Degree, minimum grades of C in BSC 2094C, NUR 1020C, NUR 1061C, NUR 2522C, NUR 1141C, NUR 2221C, NUR 1407C, NUR 2223C; **Corequisites:** None; **Course Description:** This course focuses on the concepts of healthcare organizations, technology & informatics, health care law,

healthcare quality, safety, professional identity, and clinical judgement. Emphasis is placed on leadership roles, management of care, coordination of care services, and collaboration with the healthcare team members to ensure safe and effective care for patients, families and significant others in the care environment. This course will relate nursing accountability to legal, ethical, and regulatory frameworks. This course will also emphasize the knowledge, skills, and attitude that transition from a student nurse's role to an entry-level registered nurse's role. Learning experiences will be conducted in a variety of patient care settings. Upon completion, the student will meet the end of program learning outcomes. A grade of satisfactory in the clinical/lab is required; *Effective Date:* Summer 2024 (202430).

NUR 4296 Emergency Preparedness and Disaster Nursing, CCA...R. Alvarez

Purpose: The request is made to align the course ID with the RN to BSN nursing program nomenclature; **Credit/Contact/Lab Hours:** 3/3/0; **Prerequisites:** Admission to the BSN program; NUR 3825; **Corequisites:** NUR 3825; **Course Description:** This course uses a competency-based conceptual framework to provide online RN to BSN students the opportunity to explore the various facets of natural and technological disasters while integrating public health research designs and practices. Discussions will utilize recent and historical case studies as the basis for developing the critical thinking and leadership skills needed by healthcare professionals in crisis situations. International, domestic, and regional settings will be addressed, as well as the social, economic, and political aspects of disaster planning, preparedness, and mitigation. Students also gain an understanding of basic public health concepts and methodologies. Healthy People/WHO indicators will be used in evidence-based decision-making, and public health tools such as epidemiology and biostatistics will be reinforced during the process of community assessment; **Effective Date:** Summer 2024 (202430).

MUM 2791L Music Production II-Capstone, CCA......R. Valery

Purpose: Adds an opportunity for graduating students to complete a project/portfolio initiated in the previous course (MUM 2790L) while providing additional learning opportunities; **Credit/Contact/Lab Hours:** 1/3/3; **Prerequisites:** Minimum grade of C in MUM 2790L; **Corequisites:** None; **Course Description:** Participation by students as technicians, producers and managers in the production of either a live audio event, or of a music recording project, closely paralleling the workings of a music production company. Multiple credit course. May be repeated for maximum of two credits, but grade forgiveness cannot be applied; **Effective Date:** Fall 2024 (202430).

EGN 2421 Engineering Analysis, CCA......Mohua Kar

Purpose: This course is equivalent to UCF's EGN 3420. EGN 3420 will be required by UCF for Electrical and Computer engineering majors from Fall 2024; **Credit/Contact/Lab Hours:** 3/3/0; **Prerequisites:** Minimum grade of C in MAC 2312; **Corequisites:** None; **Course Description:** Engineering applications of numerical methods using computer-aided analysis, including complex variables, curve fitting, matrix operations, Fourier series, and numerical integration; **Effective Date:** Summer 2024 (202430).

CIS 3000 Cybersecurity in Cloud Computing, CCA......A. Evans

Purpose: This course will be an elective for students in our cloud computing concentration. This will be the first cloud-specific elective for students in this pathway since they currently must choose from the software development courses to fulfill part of their electives; **Credit/Contact/Lab Hours:** 3/3/0; **Prerequisites:** Minimum grades of C in CIS 3080 and CIS 3083C; **Corequisites:** None; **Course Description:** This course is intended to Provides students with foundational and practical knowledge of cybersecurity principles for cloud computing.

Topics include cloud security design principles, authentication protocols, network access infrastructure, data protection methodologies, logging and monitoring practices, and incident response. This course prepares the student for certification exams commonly offered in the cloud computing industry; *Effective Date:* Summer 2024 (202430).

CAI 2000H Introduction to Artificial Intelligence - Honors, CCA...G. Hensel

Purpose: To allow honors students to take an elective to satisfy honors requirements; **Credit/Contact/Lab Hours:** 3/3/0; **Prerequisites:** None; **Corequisites:** None; **Course Description:** This course surveys Artificial Intelligence (AI) techniques, theories, and applications. Exposing students to AI project cycles and decision-making which involve guiding them through the comprehensive phases of initiating, developing, deploying, and evaluating AI models. Students will be introduced to various social issues and concerns surrounding AI such as ethics and bias.; **Effective Date:** Fall 2025.

CAI 2000H Introduction to Artificial Intelligence - Honors, CCA...G. Hensel

Purpose: To allow honors students to take an elective to satisfy honors requirements; *Credit/Contact/Lab Hours:* 3/3/0; *Prerequisites:* None; *Corequisites:* None; *Course Description:* This course surveys Artificial Intelligence (AI) techniques, theories, and applications. Exposing students to AI project cycles and decision-making which involve guiding them through the comprehensive phases of initiating, developing, deploying, and evaluating AI models. Students will be introduced to various social issues and concerns surrounding AI such as ethics and bias.; *Effective Date:* Fall 2025.

FSS 1051C Hearth Breads, CCA......Ken Bourgion

Purpose: Reactivating it for the ATC in Bread Baking.; **Credit/Contact/Lab Hours:** 3/6/5 **Prerequisites:** None; **Corequisites:** None; **Course Description:** Student will build on their previous knowledge and learn to mix, shape, bake, store, and distribute breads and rolls. Student will build speed and increase their proficiency in meeting production deadlines with quality products. Emphasis will be placed on increased use of traditional fermentation methods, equipment, and methods that emphasize flavor, texture, and appearance as well as techniques that increase shelf life; Course repeatable for credit only once. **Effective Date:** Spring 2025 (202520).

IDH 2930 Selected Topics in Interdisciplinary-Honors, CCA.....M. Sexton

Purpose: Proposal for a new honors seminar. Based on the student demand for more elective honors courses and the increasing popularity of City as a Text as a teaching model. New elective course for honors program. Submitting due to student demand and faculty interest; **Credit/Contact/Lab Hours:** 1-3/1-3/0; **Prerequisites:** None; **Course Description:** For students who are interested in advanced topics in Honors. May include lab and/or field work as part of the class, depending on topic. Multiple credit course. May be repeated for credit, but grade forgiveness cannot be applied; **Effective Date:** Spring 2025 (202520).

EGN 2332C Mechanics of Material, CCA......Mohua Kar

Purpose: This course is equivalent to UCF's EGN 3331C. This course is required for Civil, Construction and Environmental Engineering majors. Valencia will offer this course from Fall 2025. Both AS STEM and SAAT - Engineering students pursuing Civil, Construction and Environmental engineering will take this course; **Credit/Contact/Lab Hours:** 3/4/2/**Prerequisites:** EGN 2312, MAC 2313, and MAP2302; **Corequisites:** MAP 2302; **Course Description:** Concepts of stress, strain, strength, deflection of axial force members, shafts in torsion,

beams in flexure, combined stress, stability of columns, and design of simple elements; *Effective Date:* Fall 2025 (202610).

CAI 1700 Al for International Business, CCA......G. Hensel

Purpose: New study abroad course for AI in international business; **Credit/Contact/Lab Hours:** 1/1/0; **Prerequisites:** None; **Course Description:** This international course explores the intersection of information technology and global business, focusing on the role of artificial intelligence (AI). Students will gain a comprehensive understanding of how AI is used to drive innovation and efficiency across various industries. Through a Study Abroad Trip, students will expand their cultural awareness and explore real-world applications of AI in international settings; **Effective Date:** Fall 2025 (202610).

CAI 2100 Introduction to Practical Machine Learning, CCA.......G. Hensel

Purpose: This field is mainstream now and students need to be aware how Machine Learning and Artificial Intelligence is impacting business and society as a whole; **Credit/Contact/Lab Hours:** 3/3/0; **Prerequisites:** CAI 2000 and COP 1000 Minimum grade of C; **Corequisites:** None; **Course Description:** This course offers a practical introduction to the key ideas and tools used in machine learning (ML). Students will learn how to work with data to make predictions, spot patterns, and solve common problems. The course covers various approaches, including methods for predicting outcomes and finding relationships in data, such as using decision trees and other simple techniques. In addition, students will explore how to recognize and address fairness and bias in machine learning, ensuring responsible and ethical use of these technologies; **Effective Date:** Fall 2025 (202610).

CAI 2200 Introduction to Practical Deep Learning, CCA.......G. Hensel

Purpose: Added to AS degree; **Credit/Contact/Lab Hours:** 3/3/0; **Prerequisites:** CAI 2000 and COP 1000 Minimum grade of C; **Corequisites:** None; **Course Description:** Deep learning has powered many advances in machine learning by enabling computers to learn from large amounts of data. This course introduces deep learning concepts in a way that allows students to quickly apply them to real-world problems. Students will explore various types of neural networks and how they are used to solve tasks involving text and images. Through a mix of instruction and hands-on exercises, students will learn how to build deep learning models and apply them to practical problems in areas such as language understanding and image recognition; **Effective Date:** Fall 2025 (202610).

CAI 2300 Intro to Practical Natural Language Processing, CCA...G. Hensel

Purpose: Added to AS degree; **Credit/Contact/Lab Hours:** 3/3/0; **Prerequisites:** CAI 2000 and COP 1000 Minimum grade of C; **Corequisites:** None; **Course Description:** Natural Language Processing (NLP) is a field of artificial intelligence focused on enabling computers to work with human language. This course introduces students to the essential concepts and techniques used in NLP. Through applied learning, students will engage in practical activities to explore how language can be processed, interpreted, and generated by computers. The course covers real-world applications of NLP, such as translation, question answering, text summarization, and creating conversational systems; **Effective Date:** Fall 2025 (202610).

BCT 2931 Selected Topics in Building Construction......Andy Ray

Purpose: This new lab-based course will provide an additional elective option for all Built Environment students to gain hands-on skills with tools used in industry and practice construction management on a real project. Also open to those in other disciplines with department approval; **Credit/Contact/Lab Hours:** 3/3/2/ **Prerequisites:**

None; *Corequisites:* None; *Course Description:* This active-learning course provides students with hands-on experience in constructing an actual product including planning, project management, and execution. After completing lab safety training, students will apply theoretical knowledge to practical applications, culminating in product creation using hands tools and power equipment. Depending on project scope students may incur additional material costs; *Effective Date:* Spring 2025 (202610).

BSC 2085C Human Anatomy and Physiology I, CCA.....Olga Vazquez

Purpose: State Core course; **Credit/Contact/Lab Hours:** 4/3/3 **Prerequisites:** Satisfactory completion of all mandated courses in reading, mathematics, English, and English for Academic Purposes; **Corequisites:** None; **Course Description:** This course is the first part of a two-semester sequence in which students examine human anatomy and physiology through a systems approach based on the interaction between form and function, from the microscopic components of cells and tissues to the organismal level. Emphasis is placed on histology and the integumentary, skeletal, muscular, and nervous systems; **Effective Date:** Fall 2025 (202610).

BSC 2086C Human Anatomy and Physiology II, CCA.....Olga Vazquez

Purpose: State Core course; **Credit/Contact/Lab Hours:** 4/3/3 **Prerequisites:** Minimum grade of C in BSC 2085C or departmental approval; **Corequisites:** None; **Course Description:** Continuation of BSC 2085C, including coverage of the structures and functions of the endocrine, cardiovascular, lymphatic, respiratory, digestive, urinary, and reproductive systems with considerable emphasis on biochemistry of metabolic processes and body fluids. This course meets the General Education science requirements for graduation; **Effective Date:** Fall 2025 (202610).

PLA 1058 Foundations of Law for Paralegals, CCA......C. Mestre

Purpose: We are replacing BUL 2241 Business Law I as a required course in the Paralegal Studies degree with this new paralegal-specific Foundations of Law for Paralegals course. The new course will be taken after Introduction to Legal Practices and Ethics (PLA 1003C). While covering some of the same concepts as Business Law, the new course will be a legal specialty course will be more focused on workforce skills and require practical assignments aligned with our program outcomes. This new course incorporates Florida Department of Education requirements as well as American Bar Association requirements; Credit/Contact/Lab Hours: 3/3/0; Prerequisites: Satisfactory completion of all mandated courses in reading, English, and English for Academic Purposes and minimum grade of C in PLA 1003C; Corequisites: None; Course Description: This course provides paralegal students with an overview of tort law, constitutional law, criminal law, estate planning and probate administration, contracts, and family law. Students will prepare relevant legal documents relating to these areas of law; Effective Date: Fall 2025 (202610).

PLA 2841 Immigration Law for Paralegals, CCA......C. Mestre

Purpose: Because central Florida is a melting pot of many cultures and immigrants flock to this area for both family and employment reasons, immigration law is a growing field. Valencia's Paralegal Studies Advisory Committee (comprised of local Judges, Attorneys, and Paralegals) recommended offering this course to meet the current legal needs of the community. As such, there is an increasing need for competent paralegals who are trained in this important and expanding area of law; **Credit/Contact/Lab Hours:** 3/3/0; **Prerequisites:** Minimum grade of C in PLA 2203 and PLA 1104; **Corequisites:** None; **Course Description:** This course presents an introduction to immigration law, adjustment of status, naturalization and citizenship, including an overview of the procedural and ethical issues necessary to assist an attorney in this area; **Effective Date:** Fall 2025 (202610).

Purpose: We would like to change the course number for our Intro to the Theme Park and Attraction Management to align with UCF Rosen College of Hospitality. The course description and learning outcome from our course are very similar to those of UCF's course, and the rationale for changing the course number is to make student transfer to UCF Rosen College of Hospitality Management seamless. This was requested in conversation with UCF Rosen by their Director of Student Services and Associate Dean. This is only a change in course number; to ensure seamless transfer, the same course number will be used by UCF; Credit/Contact/Lab Hours: 3/3/0; Prerequisites: None; Corequisites: None; Course Description: This course includes a comprehensive study of the theme park industry with an emphasis on management and operations. The course will examine theme park history, park design and development, attractions, entertainment, merchandising, food & beverage, and other services that support the theme park; Effective Date: Fall 2025 (202610).

COP 2047C Python Programming, CCA......Mahendra Gossai

Purpose: Creating a new programming course to add to our computer programming degree; *Credit/Contact/Lab Hours:* 3/3/1; *Prerequisites:* Minimum grade of C in COP 1000C; *Corequisites:* None; *Course Description:* Hands on study of the Python programming language as applied to business and scientific applications. Good programming practices, and problem solving with procedural and OOP programming will be emphasized. Topics include data types, control structures, lists, dictionaries, tuples, sets, OOP classes, objects, encapsulation, inheritance, abstraction, strings, functions, file I/O, Exception Handling, and GUI; *Effective Date:* Fall 2025 (202610).

COP 2836C Web Development II, CCA......Mahendra Gossai

Purpose: Creating a new course to meet the demands in the field of web development. More frameworks are used in the field. We currently do not have a course that meets the requirements. This course will build on the foundations of Web Development I (HTML/CSS), and teach modern day frameworks that the industry demands; **Credit/Contact/Lab Hours:** 3/3/1; **Prerequisites:** Minimum grade of C in COP 2822C and COP 1000C; **Corequisites:** None; **Course Description:** Continuation of Web Development I. Advanced topics in web development using frameworks, database, front-end concepts, components, back-end services, repositories, and hosting services to build a modern full-stack web application; **Effective Date:** Fall 2025 (202610).

FIL 1000 Introduction to Film, CCA......Cheryl Robinson

Purpose: This is a new course that is being added to Humanities and Gen Ed; *Credit/Contact/Lab Hours:* 3/3/0; *Prerequisites:* None; *Corequisites:* None; *Course Description:* History and development of film, including introductory study of aesthetics and criticism. Course includes selections from the Western Canon; *Effective Date:* Fall 2025 (202610).

HUM 2210 Ancient World to the Renaissance Humanities,

CCA......E. Wallman

Purpose: New Gen Ed time period course; **Credit/Contact/Lab Hours:** 3/3/0; **Prerequisites:** None; **Corequisites:** None; **Course Description:** A study of the ideas and ideals which characterize the moral, intellectual, and aesthetic activities of the early western civilization: ancient Greece and Rome, the formative period of the Judeo-Christian tradition, and the European middle ages. Emphasis is placed upon speculative and creative nature as it

is reflected in literature, art, architecture, music, philosophy, religion, and drama. This course includes selections from the western canon; *Effective Date:* Fall 2025 (202610).

HUM 2230 Renaissance to Modern Period, CCA......E. Wallman

Purpose: New Gen Ed time-period course; *Credit/Contact/Lab Hours:* 3/3/0; *Prerequisites:* None; *Corequisites:* None; *Course Description:* A study of western culture from the renaissance to the present. Emphasis is placed upon speculative and creative nature as it is reflected in literature, art, architecture, music, philosophy, religion, and drama. This course will include selections from the western canon; *Effective Date:* Fall 2025 (202610).

Purpose: Honors section; *Credit/Contact/Lab Hours:* 3/3/0; *Prerequisites:* None; *Corequisites:* None; *Course Description:* Same as LIT 1000 with honors content. Honors program permission required; *Effective Date:* Fall 2025 (202610).

ETS 2160C Semiconductor Manufacturing Fundamentals, CCA...N. Hedayat

Purpose: Required for new program; *Credit/Contact/Lab Hours:* 3/3/1; *Prerequisites:* None; *Corequisites:* None; *Course Description:* An introductory course in the field of semiconductor manufacturing. Students will be introduced to fundamental scientific principles, processing, and applications of semiconductor manufacturing industry. Throughout the course, students will learn the types of semiconductors, the handling of semiconductors, and materials commonly used in the fabrication of semiconductor devices; *Effective Date:* Fall 2025 (202610).

ETS 2161C Introduction to Cleanroom Operation, CCA...N. Hedayat

Purpose: Required for new program; **Credit/Contact/Lab Hours:** 3/3/1; **Prerequisites:** None; **Corequisites:** None; **Course Description:** This course provides an in-depth exploration of cleanroom operation in the semiconductor industry. A study of cleanroom facility, contamination, testing, and operation. Students are introduced to several types of cleanroom standards and protocols, cleanliness and filtration requirements, environment testing and particle monitoring, and contamination issues. Course needs to be completed with a C or better grade for program progression; **Effective Date:** Fall 2025 (202610).

ETS 2162C Introduction to Cleanroom Vacuum Systems, CCA...N. Hedayat
