**Industrial Related Programs**

In a continuing effort to provide career ladder opportunities for students in career and technical education programs, Valencia College agrees to extend full college credit at no cost (other than the application for admission fee) to eligible students who have completed one of the following specified programs at Lake Technical College.

This agreement is designed to provide opportunities for students to advance who have completed one of the approved industrial related career certificate programs. The Supervision and Management for Industry AS. degree provides individuals currently working in industry with the opportunity to pursue college level education that is appropriate for supervisory and management roles and upward mobility in their respective fields.

- Air Conditioning, Refrigeration & Heating 1 & 2 (1350 Hours)
- Automotive Collision Technology Technician (1400 hours)
- Automotive Service Technology I (1050 hours)
- Automotive Service Technology 2 (750 hours) -Add'l 3 credits
- Cosmetology (1200 Hours)
- Diesel Systems Technician I (1050 Hours)
- Diesel Systems Technician 2 (750 Hours) -Add'l 3 credits
- Welding Technology (1170 hours)

**MAXIMUM AWARD OF CREDIT**

This agreement makes it possible for a student to receive the following semester hours of college credit towards the Supervision and Management for Industry AS. degree program at Valencia College which is in accordance with commonly accepted good practice in higher education.

**EDUCATIONAL PROGRAM**

Valencia and Lake Technical College faculty and staff with responsibility for supervision and coordination of the Industrial related programs and the Supervision and Management for Industry A.S. degree have assessed the adequacy of the documentation and determined that the learning outcomes, performance standards, and assessment procedures meet the college standards for college credit course work and that the learning outcomes are:

1. consistent with the course work in AS degree being articulated.
2. based on the criteria in the statewide curriculum frameworks, an alternative form of student assessment or is taught by faculty who have a minimum of an BS/BA degree in the required area or meet other described criteria.

**TRANSFERRING PROCESS**

To have the courses reported on the official Valencia College transcript, transferring students must do the following:

1. Apply for admission to Valencia College and meet the College entrance requirements.
2. Complete the College application, pay the College admission fee and declare a major in the articulated program.
3. Provide a copy of their transcripts from Lake Technical College.
4. Be accepted into Valencia within three years of completing the Lake Technical College Program.
5. Complete orientation and comply with the appropriate placement, course prerequisites and requirements of the college.
6. Meet with a Valencia Student Success Coach to verify completion of the articulated program and initiate the award of credit process. *Note: Student must provide the required documentation needed for evaluation of the approved assessments before the credit can be awarded.*

- Florida license or approved industry certification

**TRANSFERRING PROCESS (Cont.)**

7. After verifying the required documentation and evaluating the approved assessments(s), the Valencia Student Success Coach or Program Chair for the articulated program will determine eligibility, and notify the Registrar's Office of acceptable credit to be transferred and awarded. *(li ote: Credit will be awarded after the drop/add date, and the evaluation process has been completed).*

**FACULTY MEMBERS/INSTRUCTORS ELIGIBILITY FOR AWARD OF CREDIT**

This agreement also provides opportunities for teaching faculty & instructors in the specified programs. Faculty members/instructors currently teaching in one of the approved industrial related career certificate programs are eligible for the award of credit toward the Supervision and Management for Industry AS. Degree.

Faculty Members/Instructors must meet the following criteria:

1. Requirements in items 1-7 in the Transferring Process section of this agreement.
2. Furnish a Certificate of Completion from Lake Technical College or from another institution with the same program, furnish a copy of a current and valid Florida license and/or industry certification in the field of the industrial program (does not include a teaching certificate), or provide evidence of at least six years work experience comparable to the Certificate of Completion validated by Lake Technical College.
3. Provide a letter from Lake Technical College identifying this faculty member/instructor as an eligible candidate for this program.

**TERMS OF AGREEMENT**




