The ATN Nursing Program at Valencia College is Limited-Access. The ATN track is intended for students who have an active Florida license in Licensed Practical Nurse (LPN), Paramedic, Registered Respiratory Therapist (RRT), or Registered Invasive Cardiovascular Technologist. This guide outlines the admissions process, including program course requirements, application requirements, and the next steps after applying. The ATN program equips students with the skills and experience needed to succeed as a Registered Nurse (RN).

Admission Updates

1. Admission Changes (Effective Spring 2026)

2. Prerequisite Changes (Effective Fall 2025)

Beginning Fall 2025, the ATN program prerequisites have been updated. Please review the new requirements carefully before applying.

3. Updated Admission Rubric

The maximum possible admission score has been adjusted from **76 points to 70 points**, reflecting changes to prerequisite courses and ATI TEAS score weighting.

Transfer Courses	Transfer courses may need to be reviewed for potential course substitution or equivalency. This must be completed <u>before</u> submitting the program application. Transfer courses with ‘S’ or ‘P’ grades need to be reviewed for eligibility by the Health Sciences Team .

Program Course Requirements

The following points system is used to select eligible students. Student selection is based on the total number of points earned, overall GPA, Prerequisite GPA, and ATI TEAS Scores. All prerequisite courses must be completed by the application deadline with a grade of “C” or better. You may not repeat a course for grade forgiveness for which you previously earned a grade of A, B or C.

Minimum Overall GPA Requirement: 2.5

Minimum ATI TEAS Requirement: Composite Score of 65%

<p>Applicants must have <u>one</u> of the following active licenses in the State of Florida:</p> <ul style="list-style-type: none">• Licensed Practical Nurse (LPN) or• Paramedic or• Registered Respiratory Therapist (RRT) or• Registered Invasive Cardiovascular Technologist (i.e., RCIS, RCES, RCS, RVS). <p>All students must maintain a valid license, certification, or registry while enrolled in the program.</p> <p>Official Transcript of completion for LNP, Paramedic, RRT, or CVT programs must be submitted.</p> <p>All applicants (except Paramedic) must submit documentation of satisfactory completion of an intravenous therapy course that meets Florida Board of Nursing Rules as outlined in Chapter 64B9-12.005: Administration of Intravenous Therapy. How to Apply to the Nursing Program

Steps to Apply	Description
Submit a <u>Secondary Nursing Application</u> .	1. Submit a General Valencia College Application. (This must be completed first. (<i>Active students are not required to submit a General Admission Application.</i>) 2. Submit a <u>Nursing Application</u>
Valencia Student Status	Your Valencia College Student Status must be “active” before submitting a secondary Nursing Program application
Log In to the Application	Use your MyVC username and password. You must complete the entire application. * Valencia College Employees – If you are using a @valenciacollege.edu email to apply, you must contact healthscienceapplications@valenciacollege.edu for support with the application. *If you receive an error message when applying, please contact healthscienceapplications@valenciacollege.edu for support with the application
Submit the Application	Pay the \$15 non-refundable application fee. The application is NOT complete until payment is received.

What Happens After You Apply

Application Review Process: The application reviews will occur over 4-6 weeks after the closing deadline. Admissions are based on a competitive points system.

Application Notification: Your application decision will be sent to your MyVC email. You must monitor your email for updates. You will receive one of the following responses below:

NURSING CORE PERFORMANCE STANDARDS FOR ADMISSION AND PROGRESSION

Nursing is a practice discipline with cognitive, sensory, affective, and psychomotor performance requirements. Based on these requirements, the following list of "Core Performance Standards" has been developed. Each standard has an example of an activity, or activities, that a student will be required to perform while enrolled in the Nursing Program. These standards are a part of each Nursing course and of the professional role expectation of a Nurse.

For the Nursing Program, a qualified individual with a disability is one who, with or without reasonable accommodations or modifications, meets the essential eligibility requirements for participation in the program. Valencia College: School of Health Sciences makes no preadmission inquiries concerning an applicant's disability status. Information related to an applicant's disabilities is not a part of the information reviewed by the Admission Committee.

These Performance Standards should be used to assist students in identifying the academic and clinical expectations for all students. Students needing reasonable accommodations to fulfill required program outcomes or clinical expectations are encouraged to contact the [Office for Students with Disabilities](#) to engage in an interactive process regarding their request. Critical Thinking	Critical thinking ability sufficient for clinical judgment	Identify cause-effect relationships in clinical situations, develop nursing care plans
Interpersonal	Interpersonal abilities sufficient to interact with individuals, families and groups from a variety of social, emotional, cultural, and intellectual backgrounds.	Establish rapport with patients, significant others, peers, and other members of the healthcare team
Communication	Communication abilities sufficient for interaction with others in verbal and written form.	Effectively explain treatments and procedures; initiate health teaching; document and interpret nursing actions and patient responses
Mobility	Physical abilities sufficient to move from room to room and maneuver in small spaces.	Move around in patients' rooms, workspaces, and treatment areas; perform CPR; position, transfer, and lift patients without restrictions
Motor Skills	Gross and fine motor abilities sufficient to provide safe and effective care.	Calibrate and use equipment
Hearing	Auditory abilities sufficient to monitor and assess patient needs, and to provide a safe environment.	Hears monitor alarms, emergency signals, auscultator sounds, and cries for assistance
Visual	Visual acuity sufficient for the provision of safe patient care. Ability to read and record on printed and electronic records.	Observes patient responses; perform physical examination; perform nursing interventions
Tactile	Tactile ability sufficient for physical assessment	Perform physical examination and interventions
