



## Associate in Science Degree in Nursing, Traditional Track (ASN)

### Admission Guide | Catalog Year: 2026-2027

#### Program Overview

The Traditional Associate in Science Degree in Nursing (ASN) at Valencia College is a limited-access, four-term program designed for students seeking to become Registered Nurses (RNs). Admission to Valencia College does not guarantee admission to the Nursing Program. This guide outlines program eligibility, admission requirements, application steps, and key deadlines to support applicants through the admission process.

#### Admission Updates (Effective Fall 2026)

##### Admission Requirement Updates

- Applicants must earn a minimum ATI TEAS composite score of 78.

##### Admission Review & Selection Updates

- The AS Nursing program no longer uses a point-based admission rubric.
- Applicants who meet minimum admission requirements will be ranked and selected based on:
  1. ATI TEAS composite score
  2. Prerequisite GPA

#### **Program Location & Delivery Format**

Students admitted to the Traditional Track in Nursing are assigned to either the West Campus or Osceola Campus at the time of admission. Lecture courses are delivered at the assigned campus. Lab and simulation experiences are primarily held at the assigned campus, though students assigned to the Osceola Campus occasionally attend required lab or clinical orientation activities at the West Campus. Clinical experiences take place at affiliated healthcare agencies throughout Central Florida.

Review Program Requirements	Confirm that you meet all program requirements outlined in this guide, including prerequisite coursework, minimum prerequisite GPA, and ATI TEAS composite score requirements.
Confirm Eligibility – Program Participation Requirements	<p>Before applying, applicants must meet the following eligibility requirements:</p> <ul style="list-style-type: none"> <li>• Applicants must be 18 or older by the <u>start date</u> of the program</li> <li>• Eligible applicants include U.S. Citizens, U.S. Permanent Residents, International Students and individuals with Deferred Action for Childhood Arrivals (DACA), Temporary Protected Status (TPS), Refugee, or Asylee status.</li> <li>• Applicants who are not U.S. Citizens or Permanent Residents must have a valid <a href="#">Employment Authorization Document (EAD)</a> for clinical placement purposes.</li> </ul> <p>Please note, graduates must have a Social Security Number (SSN) to be eligible for NCLEX-RN licensure.</p>
Apply to Valencia College	<p>Submit a Valencia College admission application and complete ALL steps outlined in <a href="#">Steps to Enrollment</a>.</p> <p><i>Note: This is the General Admission application and not the secondary Health Sciences (Nursing) application.</i></p>
Meet with a Student Success Coach	After applying to Valencia College, students are strongly encouraged to meet with their assigned Student Success Coach early and regularly while completing prerequisite coursework. Ongoing advising support helps ensure all admission and eligibility requirements are met prior to submitting the Nursing program application.
Submit Transcripts	<p>Submit high school and college transcripts from all institutions attended. Transcripts must be posted to your Valencia College record before submitting the Nursing application deadline (recommend 3 months prior).</p> <p>Students using credit by exam (such as AP, CLEP, or IB) for prerequisite coursework must request official score reports from the appropriate testing agency.</p> <p><i>Transfer students are not considered “first-time-in-college” and are not required to submit a high school transcript.</i></p>

Verify Transfer Courses Equivalency (if applicable)	Transfer courses may need to be reviewed for potential course substitution or equivalency. This must be completed <u>before</u> submitting the secondary health science application (nursing application).
Complete Program Prerequisites	All required prerequisite courses must be completed with a grade of C or better prior to the application deadline. Applicants must earn a minimum combined prerequisite GPA of 3.0 across the required courses to be eligible for admission consideration. Refer to the Admission Requirements section for full details.
ATI TEAS Testing & Score Submission	<p>Applicants must earn a minimum composite score of 78 on the ATI TEAS exam.</p> <p>You may take the ATI TEAS up to three times within a 12-month period, however you must allow 30 days between retakes. The 12-month period begins at the date of a first attempt.</p> <p>Applicants who take the ATI TEAS exam outside of the Valencia College Assessment Center must request official scores from ATI. After requesting scores, applicants must complete the <a href="#">ATI Score Matching Request Form</a> so scores can be properly matched to their Valencia College record.</p>
Core Performance Standards	Review the Core Performance Standards to ensure you are able to meet program requirements, with or without reasonable accommodations.

## Program Admission Requirements

To be eligible for admission consideration to the Traditional Associate in Science Degree in Nursing (ASN) program, applicants must meet all minimum requirements by the application deadline.

Academic Standing	Must be in Good Academic Standing at Valencia College at the time of application.
Minimum ATI TEAS Composite Score	78
Completion of Prerequisite Coursework & minimum 3.0 pre-req GPA	All required prerequisite courses must be completed with a grade of C or better prior to the application deadline. Applicants must earn a minimum combined prerequisite GPA of 3.0 across the courses to be eligible for admission consideration.

## How to Apply to the Nursing Program

Applying to the Nursing Program is a two-step process. Applicants must complete both the Valencia College General Admission process (if not already active) and the secondary Health Science Program application by the published deadline (pg. 1).

Steps to Apply	Description
Confirm Valencia College Student Status	Before applying to the Nursing Program, applicants must have an Active Valencia College student status. <ul style="list-style-type: none"><li>New students must first submit a General Valencia College Application</li></ul>
Submit the Secondary Health Science Application (Nursing Program)	Submit the Health Science Application and select Nursing during the published application window at: <a href="http://valenciacollege.edu/apply-health">valenciacollege.edu/apply-health</a> . <ul style="list-style-type: none"><li>Applications must be submitted using your MyVC username and password</li><li>Applicants attempting to access the application outside the published window will encounter an error message.</li></ul>
Application Support	<ul style="list-style-type: none"><li>If you receive an error message during the published application window, contact <a href="mailto:healthscienceapplications@valenciacollege.edu">healthscienceapplications@valenciacollege.edu</a></li><li>Valencia College employees using a @valenciacollege.edu email address must contact the same inbox for assistance.</li></ul>
Submit Application Fee	<ul style="list-style-type: none"><li>Pay the \$15 non-refundable application fee</li><li>Applications are not complete—or reviewed—until payment is received</li></ul>

## What Happens After You Apply

Application Review Process: Applications are reviewed approximately four to six weeks after the closing deadline using a competitive review process, prioritizing ATI TEAS composite score and prerequisite GPA. Admission decisions are communicated via the applicant's MyVC email.

## Admission Decisions

Decision Type	Description
Selected	Offered admission into the Program. Applicants must confirm acceptance by the stated deadline to secure their seat.
Alternate	Offered placement on the alternate list. Applicants must confirm acceptance of their alternate status by the stated deadline to remain eligible to be offered a seat if one becomes available. Admission is not guaranteed.
Not Selected	Met minimum admission requirements but was not selected due to limited program capacity.
Ineligible	Did not meet one or more program eligibility or admission requirements by the application deadline.

## Requirements If Selected for Admission

Mandatory Nursing Orientation: All students selected for admission must attend the Mandatory Nursing Orientation, which is held prior to the start of the program.

Tdap (Tetanus, Diphtheria, Pertussis)</li> <li>6. Tuberculosis (TB) screening*</li> <li>7. ## NURSING CORE PERFORMANCE STANDARDS FOR ADMISSION AND PROGRESSION

Nursing is a practice discipline with cognitive, sensory, affective, and psychomotor performance requirements. Based on these requirements, the following list of "Core Performance Standards" has been developed. Each standard has an example of an activity, or activities, that a student will be required to perform while enrolled in the Nursing Program. These standards are a part of each Nursing course and of the professional role expectation of a Nurse.

For the Nursing Program, a qualified individual with a disability is one who, with or without reasonable accommodations or modifications, meets the essential eligibility requirements for participation in the program. Valencia College: School of Nursing makes no preadmission inquiries concerning an applicant's disability status. Information related to an applicant's disabilities is not a part of the information reviewed by the Admission Committee.

These Performance Standards should be used to assist students in identifying the academic and clinical expectations for all students. Students needing reasonable accommodations to fulfill required program outcomes or clinical expectations are encouraged to contact the [Office for Students with Disabilities](#) to engage in an interactive process regarding their request. Critical Thinking	Critical thinking ability sufficient for clinical judgment	Identify cause-effect relationships in clinical situations, develop nursing care plans
Interpersonal	Interpersonal abilities sufficient to interact with individuals, families and groups from a variety of social, emotional, cultural, and intellectual backgrounds.	Establish rapport with patients, significant others, peers, and other members of the healthcare team
Communication	Communication abilities sufficient for interaction with others in verbal and written form.	Effectively explain treatments and procedures; initiate health teaching; document and interpret nursing actions and patient responses
Mobility	Physical abilities sufficient to move from room to room and maneuver in small spaces.	Move around in patients' rooms, workspaces, and treatment areas; perform CPR; position, transfer, and lift patients without restrictions
Motor Skills	Gross and fine motor abilities sufficient to provide safe and effective care.	Calibrate and use equipment
Hearing	Auditory abilities sufficient to monitor and assess patient needs, and to provide a safe environment.	Hears monitor alarms, emergency signals, auscultator sounds, and cries for assistance
Visual	Visual acuity sufficient for the provision of safe patient care. Ability to read and record on printed and electronic records.	Observes patient responses; perform physical examination; perform nursing interventions
Tactile	Tactile ability sufficient for physical assessment	Perform physical examination and interventions
