STUDENT ACCOUNTING

Audit Report: CA2017-103 Issued: March 29, 2018

The objectives of the engagement were to evaluate and assess the appropriateness of the College's tuition and fees collected as designated by Florida Statute and College policy and procedures. To meet these objectives, we focused on evaluating and testing operational internal controls of the budget, collection and accounting of student tuition and fees. The scope of the audit was from January 2017 through February 2018.

Overall the processes in place with regards to Student Accounting processes are adequate and operating in a satisfactory manner. There were no material audit observations noted during this engagement.
