RE: ANNUAL PRE-QUALIFICATION OF GENERAL CONTRACTORS FOR THE PERIOD OF JULY 1, 2020 THROUGH JUNE 30, 2021

On May 2, 2020, Valencia College issued Request for Qualifications (RFQu) 2020-22, *General Contractors Annual Pre-qualification*. Pursuant to Florida Statute 1013.46(2), State Requirements for Educational Facilities (SREF), Chapter 4(4.1), and College Board Rule 6Hx28:11-06, General Contractors must be qualified to be eligible to compete in construction projects at all dollar levels that arise during the qualification period. Pre-qualification of construction contractors ensures that the qualifications of construction firms bidding meet or exceed State Statutes, SREF requirements, and College Board Rule. The RFQu information was advertised in the Orlando Sentinel, and posted on Valencia's Procurement web-site and the College's public solicitation portal, VendorLink.

Fifty-one (51) firms submitted qualification applications.

An online public evaluation meeting was held on Wednesday June 3, 2020. The prequalification criteria included professional qualifications and competence applicant's, past performance and experience, state and college requirement compliance, references, signature acknowledgement and certification, and applicant's financial resources and capability.

The evaluation committee reviewed the submissions and recommends pre-qualification of forty-eight (48) firms. There is no fiscal impact to the College as a result of this action.

RECOMMENDATION:

The President recommends that the District Board of Trustees of Valencia College authorize the attached list of General Contractors for the period of July 1, 2020 through June 30, 2021 pursuant to State Requirements for Educational Facilities (SREF), Chapter 4(4.1), and College Board Rule 6Hx28:11-06.
