2122-167 A.S. in Construction and Civil Engineering Technology, CPM......Andy Ray *Purpose:* Changes to State Gen Ed requirements. Program is not allowing further changes - we prefer the language to read: Communications ENC 1101 Freshman Composition I and Mathematics See Gen. Ed. Core Requirement; *Effective Date:* Fall 2022 (202310).

Proposal 2122-167 was approved by consensus.

2122-168 A.S. in Computer Aided Drafting and Design, CPM......Andy Ray *Purpose:* David Mueller with State of Florida notified us in October that we can reduce the total hours in the program to 60 to match other AS programs. This will reduce the Discipline Electives in the program by 2 credits from 8 to 6; *Effective Date:* Fall 2022 (202310).

Proposal 2122-168 was approved by consensus at the meeting, but the curriculum office was informed after the meeting that the program hours change had not been approved by the state as yet.

Proposal 2122-168 was tabled.

2122-169 A.S. in New Media Communication, CPM......Courtney Lewis *Purpose:* Legislative mandate. To improve student learning outcomes; *Effective Date:* Fall 2022 (202310).

In addition to the mandated changes, they want to remove elective credits in the Mobile Journalism Specialization and add JOU 2100C to remove a hidden prerequisite issue.

Proposal 2122-169 was approved with the above change.

2122-170 HUN 2930 Selected Topics in Nutrition, CCA.........K. Bartholomew *Purpose:* A selected topics course is needed for study abroad Summer 2023. We will also use this selected topics course for other study abroad courses and other special needs that come up for students; *Credit/Contact/Lab:* 1-3/1-3/0; *Prerequisites:* None; *Co-requisites:* None; *Catalog Course Description:* Seminars offered for students interested in special topics in nutrition. Topics selected from special areas of food, nutrients, health, disease management, and sustainability as interest of students and professor dictate. Multiple credit course. May be repeated for credit and grade forgiveness cannot be applied; *Effective Date:* Fall 2022 (202310).

Proposal 2122-170 was approved by consensus.

2122-171 A.S. in Nursing (Articulated A.S. to B.S. Career Path), CPM......R. Alvarez *Purpose:* Remove DEP 2004 and add POS 2041C to comply with state Civic Literacy graduation requirement and align with accreditation standards of no hidden courses; *Effective Date:* Fall 2022 (202310).

Proposal 2122-171 was approved by consensus.
