2122-174 ARC 1201C Theory of Architecture, CCM.....A Caldero Figueroa
Purpose: This course should not have a corequisite; **Revised Co-requisites:** None; **Catalog Course Effective Date:** Fall 2022 (202310).

2122-175 ARC 1302C Architectural Design II, CCM.....A Caldero Figueroa
Purpose: ARC 1201C should not have corequisites; **Revised Co-requisites:** None; **Catalog Course Effective Date:** Fall 2022 (202310).

2122-176 Criminal Justice-Law Enforcement Academy Track, CPM.....D. Heffernan
Purpose: We removed SPC 1608 Fundamentals of Speech and added POS 2041 U.S. Government to meet HB1507 requirements so it will be consistent with the CJAS degree. In Term 1 we removed "Mathematics or Science: See Gen Ed Core Requirements (MGF 1106 recommended)" and entered MGF 1106: Liberal Arts Mathematics I to be consistent with CJ AS degree program. In Term 3 we removed, "Gen Ed. Elective: See Gen. Ed. Requirement" and entered Science: See Gen Ed. Core Requirement ~1 to meet HB1507 ensuring one core course in each gen. ed. area; **Effective Date:** Fall 2022 (202310).

2122-179 NUR 2XX1C ATN-Health and Illness Concepts of Mental Health, CCA.....Ruby Alvarez

Purpose: ATN is transitioning to concept based curriculum. The course already exist for the traditional track therefore we needed to give the course a different name to meet the needs of the ATN students; **Credit/Contact/Lab:** 3/5/3; **Prerequisites:** Admission to Nursing A.S. Degree Program, minimum grade of C in NUR 1100C, NUR 2XXXC, NUR 2440C; **Co-requisites:** NUR 2210C; **Catalog Course Description:** This course includes concepts within the three domains of the health care recipient, health and illness, and professional nursing and health care. Emphasis is placed on each domain's concepts, including stress, coping, mood, cognition, addiction, development, and safety. The students will develop communication, assessment, intervention, and evaluation of mental health within the healthcare system. A grade of satisfactory in the clinical/lab is required. This course must be completed with a grade of C or better for program progression; **Effective Date:** Fall 2022 (202310).

Proposal 2122-179 is approved pending approval from the state.

2122-180 NUR 2XXXC ATN-Health and Illness Concepts Physical and Health Assmnt., CCA.....Ruby Alvarez

Purpose: ATN is transitioning to concept based curriculum. The course already exist for the traditional track therefore we needed to give the course a different name to meet the needs of the ATN students; **Credit/Contact/Lab:** 3/5/3; **Prerequisites:** Admission to the Nursing Accelerated A.S. Degree Program; **Co-requisites:** NUR 1100C and NUR 2440C; **Catalog Course Description:** This course includes the concepts within the domains of health care recipient, health and illness, and professional nursing and health care. Emphasis is on physical and health assessment for clients throughout the lifespan. Upon completion, students will provide safe nursing care incorporating the concepts identified in this course. A grade of satisfactory in the clinical/lab is required. This course must be completed with a grade of C or better for program progression; **Effective Date:** Fall 2022 (202310).

2122-181 NUR 2210C ATN-Concepts of Adult Health I, CCA.....Ruby Alvarez

Purpose: Change in curriculum from medical model to concept based; **Credit/Contact/Lab:** 5/3/2; **Prerequisites:** Admission to the Nursing Accelerated A.S. Degree Program; **Co-requisites:** NUR 2XX1C; **Catalog Course Description:** This course reinforces the three domains of the health care recipient, health and illness, and professional nursing and healthcare. Emphasis is placed on hemostasis & regulation and protection. The course will include the concepts of fluid & electrolytes, gas exchange, perfusion, hormonal regulation, glucose regulation, and elimination. Interrelated concepts of: communication, culture, elimination, ethics, gas exchange, health promotion adherence, infection/immunity, interpersonal violence, mobility, perfusion, professional identity, safety, stress & coping, technology & informatics, and tissue integrity. Upon completion, students will provide safe nursing care incorporating the concepts identified in this course. A grade of satisfactory in the clinical/labs required; **Effective Date:** Fall 2022 (202310).

2122-182 NUR 1100C Transition into Professional Nursing Concepts, CCM.....Ruby Alvarez

Purpose: Transition to concept-based curriculum; **Revised Course Title:** ATN - Transition into Professional Nursing Concepts; **Revised Course Hours:** 4/2/2; **Revised Co-requisites:** NUR 2440C, NUR 2XXXC; **Catalog Course Effective Date:** Fall 2022 (202310).

2122-183 NUR 2000C ATN Concepts of Patient Care Management and Leadership-Practicum, CCM.....Ruby Alvarez

Purpose: Transition to concept-based curriculum; **Revised Prerequisites:** Minimum grades of C in NUR 2XXXC, NUR 1100C, NUR 2440C, NUR 2XX1C, NUR 2210C, NUR 2522C and NUR 2216C; **Revised Co-requisites:** NUR 2216C; **Catalog Course Effective Date:** Fall 2022 (202310).

2122-184 NUR 2217C ATN Concepts of Adult Health II, CCM.....Ruby Alvarez

Purpose: Transition to concept-based curriculum; **Revised Prerequisites:** Minimum grades of C in NUR 2XXXC, NUR 1100C, NUR 2440C, NUR 2210C, NUR 2XX1C; **Catalog Course Effective Date:** Fall 2022 (202310).

2122-185 NUR 2440C ATN Concepts of Maternal Child Health, CCM.....Ruby Alvarez

Purpose: Transition to concept-based curriculum; **Revised Co-requisites:** NUR 1100C, NUR 2XXXC; **Catalog Course Effective Date:** Fall 2022 (202310).

Proposal 2122-185 is approved pending approval from the state.

2122-186 Nursing, Accelerated Track (Limited Access), CPM.....Ruby Alvarez

Purpose: This track is transitioning from medical model curriculum to concept based curriculum, Revise program hours; **Effective Date:** Fall 2022 (202310).

Proposal 2122-186 was approved by consensus.

2122-187 COP 4530C Applied Data Structures and Algorithms, CCA.....Lisa Macon

Purpose: This elective was requested by current and past program students. They have been running into questions at job interviews that specifically require students to know specific algorithms and data structures used to solve problems; **Credit/Contact/Lab:** 3/3/1; **Prerequisites:** Minimum grade of C in COP 3330C or COP 2805C; **Co-requisites:** None; **Catalog Course Description:** An overview of data structure concepts such as arrays, stack, queues, trees, and others. Discussion of the varieties, benefits, drawbacks, and performance implications of data structures. programming styles, and run-time representations. Algorithms for sorting, searching and manipulating data structures will also be examined; **Effective Date:** Fall 2022 (202310).

Students have been feeling unprepared although components of this course are taught in other places. They plan to try it out to see how beneficial it is for students. They may make it a requirement in the future.

Proposal 2122-187 were approved by consensus.

5. Discussion Items.

- a. Bachelor's Degrees, General Education & New Student Experience (See attached Situation, Background, Assessment, and Recommendation on Legislative Changes):

Students that have already completed AS shouldn't have to take New Student Experience course, so they are recommending those students have any General Education course to satisfy the General Education requirement.

Committee member explained that their child that was recently admitted to UF and was short of the language requirement so they wondered if it could be a foreign language course for the AA degree.

Cheryl advised that there is an existing Foreign Language Proficiency requirement for an AA.

- b. Receiving feedback on proposed course additions to the General Education Program:

The committee had a brief discussion on if there should be a new mode of receiving feedback to proposed General Education changes. The committee agreed to a self-enrolled canvas course for communication of proposed changes. This will allow for discussion of the proposals to occur.
