Purpose: This course will be part of the Photonics specialization offered under the AS STEM and it will be the equivalent of OSE 2050 Geometric Optics at CREOL-UCF; **Credit/Contact/Lab Hours:** 1/2/1; **Prerequisites:** None; **Corequisites:** None; **Course Description:** Hands-on experiments on real-life optics & photonics, to develop abilities in design, control, and communication with photonic devices used in computers and/or smartphones; **Effective Date:** Fall 2024 (202510).

2324-155 ETS 2212 Foundations of Photonics, CCA.....R. Bunea
Purpose: This course will be part of the Photonics specialization offered under the AS STEM and it will be the equivalent of OSE 3052 Foundations of Photonics at CREOL-UCF; **Credit/Contact/Lab Hours:** 3/3/0; **Prerequisites:** Minimum grade of C in ETS 2210C, PHY 2049C, and MAC 2313; **Corequisites:** ETS 2212L; **Course Description:** Introduction to wave and photon models of light. Polarization and coherence. Interference and diffraction of light. Interferometers and spectrometers; **Effective Date:** Fall 2024 (202510).

The prerequisite was changed to: Minimum grades of C in PHY 2049C, and MAC 2313

2324-156 ETS 2212L Foundations of Photonics Laboratory, CCA.....R. Bunea
Purpose: This course will be part of the Photonics specialization offered under the AS STEM and it will be the equivalent of OSE 3052L Foundation of Photonics Laboratory at CREOL-UCF; **Credit/Contact/Lab Hours:** 1/2/2; **Prerequisites:** None; **Corequisites:** ETS 2212; **Course Description:** The laboratory course is designed to reinforce the concepts discussed in class with a hands-on approach and to allow the students to learn laboratory techniques for observing optical phenomena and quantitative experimental characterization in geometrical optics, polarization, interference, and diffraction; **Effective Date:** Fall 2024 (202510).

2324-157 ETS 2215 Geometric Optics, CCA.....R. Bunea
Purpose: This course will be part of the Photonics specialization offered under the AS STEM and it will be the equivalent of OSE 3200 Geometric Optics at CREOL-UCF; **Credit/Contact/Lab Hours:** 3/3/0; **Prerequisites:** Minimum grade of C in ETS 2210C and PHY 2048C; **Corequisites:** ETS 2215L; **Course Description:** Fundamentals of geometrical optics. Geometrical theory of image formation. Chromatic and monochromatic aberrations. Optical systems; **Effective Date:** Fall 2024 (202510).

The prerequisites were changed to: Minimum grade of C PHY 2048C.

2324-158 ETS 2215L Geometric Optics Laboratory, CCA.....R. Bunea

Purpose: This course will be part of the Photonics specialization offered under the AS STEM and it will be the equivalent of OSE 3200L Geometric Optics at CREOL-UCF; **Credit/Contact/Lab Hours:** 1/2/2; **Prerequisites:** None; **Corequisites:** ETS 2215; **Course Description:** Introductory optics lab that studies the behavior of light as rays. Reflection, refraction, and transmission. Lenses, mirrors, and prisms. Image formation and beam manipulation. Measure and characterize archetypal optical systems such as telescopes, cameras, and microscopes; **Effective Date:** Fall 2024 (202510).

2324-159 ETS 1210C Intro to Photonics, CCD.....Radu Bunea
Purpose: Revise course number; **Revised Course Number:** ETS 2210C; **Effective Date:** Fall 2024 (202510).

2324-160 ETS 2210C Principles of Photonics, CCA.....Radu Bunea
Purpose: The course prefix and title did not reflect the level of the course and the prerequisites.; **Credit/Contact/Lab Hours:** 3/4/2; **Prerequisites:** MTB 1329 or MAC 1105 and EET 1214C or ETS 1211C; **Corequisites:** None; **Revised Course Description:** A course exploring the principles of Photonics theory, concepts, and applications. Contents include the nature and properties of light, light sources, human vision, and laser safety, basics of geometric and physical optics, and basic principles and applications of holography. Laboratory experimentations will complement theoretical concepts of the course; **Effective Date:** Fall 2024 (202510).

2324-190 SYG 2000 Introductory Sociology, CCM.....A. Trierbeiniek
Purpose: Changes made to move SYG 2000 from core to institutional and course description change to reflect the course description approved by the state; **Revised Prerequisites:** Minimum grade of C in ENC 1101; **Revised Course Description:** In this course, students will gain an understanding of the basic sociological concepts and vocabulary, including the methodological tools, sociological perspectives, and scientific procedures used by social scientists to collect data and conduct research. Topics generally include: society and culture, institutions, socialization, social control, influences, crime, change, groups, sex, race and ethnicity, family, class, and population; **Effective Date:** Fall 2024 (202510).

There was a question about if the course would count as institutional credit and vice versa if the student switched catalog years. As of now it would not be interchangeable.

2324-192 **FFP 1302C** **Apparatus Operations, CCA.....Dan Diehl**
Purpose: The Advisory Council requested that we embed this course in the AS degree so students can earn the Fire Apparatus Operator Certification; **Credit/Contact/Lab Hours:** 3/3/1; **Prerequisites:** Minimum grade of C in FFP 1301; **Corequisites:** None; **Course Description:** This course covers the laws, rules, and driving techniques for emergency vehicles. A practical portion of the course will include fire ground evolutions using pre-connected lines, tandem pumping, drafting, relays, and master streams. Practice and proper demonstration of fire apparatus on a road or closed driving course. Students will need proper attire for water-pumping exercises. After completing this course and FFP 1301, the student will be eligible to take the State Pump Operator certification exam through the Florida State Fire College. This course must be completed with a 70 percent C grade to receive credit; **Effective Date:** Summer 2024 (202430).

2324-193 **Fire Science Technology Academy Track, CPM.....Dan Diehl**
Purpose: To delete a course, HSC 1531 MEDICAL TERMINOLOGY, that has proven unnecessary and replace it with a course, the advisory council requested FFP 1302 APPARATUS OPERATIONS. This will make the students eligible for the State Pump Operator certification exam through the Florida State Fire College. Replace MGF 1106 with MGF 1130 as MGF 1106 will no longer be taught. Remove Philosophy and replace with Fire Behavior and Combustion; **Effective Date:** Fall 2024 (202510).

Honors program permission required; **Effective Date:** Fall 2024 (202510).

2324-204 HSC 2721 Accessing and Analyzing Health Information, CCM.....B. Pierre
Purpose: To align better with the state course description; **Revised Course Description:** This course focuses on providing students with the comprehensive knowledge and skill base needed to make evidence-based decisions. This course introduces the most frequently used statistical techniques for analyzing healthcare data. The course explores concepts related to complex data analysis within the healthcare environment and will focus on healthcare practice outcomes for quality improvement. Methods of critical evaluation of data needed to support planning, implementation, and evaluation will be emphasized. Students will address concerns in the professional work setting by analyzing decisions made through use of evidence; **Effective Date:** Fall 2024 (202510).
