1314-367Basic Electronics Technician Certificate, CPM......Deb HallPurpose:Remove EET 1036C (6credit hours) and add EET 1025C (3 credit hours) to match the statemandated program length for this certificate.

Proposal 1314-367 was approved by consensus.

1314-368Fire Officer I Certificate, CPD......Dan DiehlPurpose:Certificate has been deleted from the DOE framework; Effective Date:Fall 2014 (201510).

1314-369 Fire Officer II Certificate, CPD......Dan Diehl *Purpose:* Certificate has been deleted from the DOE framework; *Effective Date:* Fall 2014 (201510).

Proposals 1314-368 and 1314-369 was approved by consensus.

1314-370 Fire Company Management Certificate, CPA......Dan Diehl Purpose: To replace the deleted Fire Officer I & Fire Officer II certificates; *Effective Date:* Fall 2014 (201510). 1314-371 A.S. in Fire Science Technology, CPM......Dan Diehl *Purpose:* The Florida Bureau of Fire Standards & Training changed the Fire officer certifications that are embedded in the Fire Science Technology AS degree; *Effective Date:* Fall 2014 (201510).

Proposals 1314-370 and 1314-371 was approved by consensus.

4. Discussion Items

There are no Discussion Items for the June Agenda.

5. Information Items

- The CCC inadvertently approved a curricular change for the Articulated Pre-Major: Electrical and Computer Engineering Technology (Valencia) program. The issue with this change is that it removed a 4 credit science course, PHY 2049C, and replaced it with EET 1015C. It was changed back in our 2014 catalog since the approved change would not allow our students to graduate since they would be 3 credits short in science. I recognize that EET 1015C is a prereq to EET 1025C, but students need to graduate with their AA before they can go into our Bachelor degree program.
- The CCC approved the following CCM for BSC 2093C.

1314-232 BSC 2093C Human Anatomy and Physiology I, CCM...... Lisa Sward *Purpose:* Updated Catalog Course Description to include General Education requirements; and revised prerequisites; *Revised Prerequisites:* Satisfactory completion of all mandated courses and a minimum grade of C in BSC 1010C or MCB 2010C; or a minimum grade of B for acceptable high school courses, such as Honors Biology and Honors Chemistry; or AP Biology and AP Chemistry (Previously: Satisfactory completion of all mandated courses in reading, mathematics, English, and EAP; and a minimum grade of C in: Honors high school biology or AP biology and Honors high school chemistry or AP chemistry; or BSC 1010C; *Revised Catalog Course Description:* Scientific method, biochemical processes of life, cells, tissues, structure and function of integumentary, skeletal, muscular, endocrine and nervous systems, and organs of special senses. Lab exercises emphasize anatomic and physiologic principles associated with classroom work. This course meets the General Education science requirement for graduation. (Special Fee: \$62.00); *Effective Date:* Fall 2014 (201510).

The committee pointed out that this prerequisite revision would increase the numbers of students coming in to see advisors and deans for overrides. The committee agreed that the prerequisites should not be revised, but the minimum required grades should be a B in all of the prerequisite courses.

We removed the "minimum grade of B for BSC 1010C, since students aren't eligible for grade forgiveness in courses in which they earn an A, B or C.
