Karen Borglum asked for a moment to make a couple of announcements. She thanked Kim Adams for her hard work and good job in working with faculty to put together their proposals, as well as for putting together the agenda and organizing the meeting. Karen also announced that Kim recently graduated from Valencia College with an Associate in Arts Degree. Next, Karen thanked Ana Caldero Figueroa for graciously making her signature Mexican Salad as a treat for everyone at the meeting.

1. **Review of Minutes – January 11, 2012 (Attachment)**

John Niss asked if everyone has had a chance to review the January minutes. He said that he would like to propose a small change. He had discussed the proposed change with Kim Adams; however, since the proposals had been approved in the particular way the minutes were worded, it was decided to present the minutes as approved and ask for the change at the meeting today.

MGF 1106 and MGF 1107 were approved with the wording, “Minimum grades of C in . . .;” however, the prerequisites are OR, not AND. Therefore, it is not necessary to make the word “grade” plural, since the student only needs to take one of the listed courses. The Committee agreed to this revision by consensus.

Other than the minor change above, the minutes were approved by consensus.

COP 1000 Introduction to Programming Concepts

The Consent Agenda was approved by consensus.

3. Regular Agenda

The following three proposals – 1112-069; 1112-071; and 1112-073 were presented at the January 11, 2012 CCC meeting. The two courses, GRA 2225C and GRA 2755C, both have a lab component; however, the lab fees had not been determined. It was the consensus of the Committee for the proposal initiator to go back to the department and determine the fees, bringing them back to the CCC for this meeting. Proposal 1112-073, a Program Modification, was deferred as well, until the fees issue was resolved.

1112-069 GRA 2225C Advanced Typography, CCAKristy Pennino
Purpose: This course is being added as a "Graphics Elective" so students have more opportunities to supplement their graphic design education while giving them additional elective options that will transfer to institutions offering similar courses ; **Catalog Course Description:** This course provides students with the opportunity to advance their typographic understanding and application beyond the fundamental level. Students will be given the opportunity to design advanced typographic solutions for their visual portfolio; **Prerequisites:** Minimum grade of C in GRA 1206C and GRA 1413; **Co-requisites:** None; **Credit/Class (Lecture)/Lab Hours:** 3/3/1; **Special Fees:** \$46.00; **Effective Date:** Fall 2012 (201310).

Proposal 1112-069 was approved with the following revision: change the effective date to Summer 2012 (201230). The reason for this is that the department would like to begin offering the course for the summer term, and this will allow them to use the number assigned, rather than offering it as a selected topics course.

1112-071 GRA 2755C Web Development for Designers, CCA.....Kristy Pennino
Purpose: This course is being added as a "Graphics Elective" so students have more opportunities to supplement their graphic design education while giving them additional elective options that will transfer to institutions offering similar courses ; **Catalog Course Description:** This course allows front-end web designers to further develop their skills and understanding in current industry-standard back-end web development; **Prerequisites:** Minimum grades of C in GRA 2143C and GRA 2132C; **Co-requisites:** None; **Credit/Class (Lecture)/Lab Hours:** 3/3/1; **Special Fees:** \$46.00; **Effective Date:** Fall 2012 (201310).

Proposal 1112-071 was approved with the following revisions: 1) add "or department approval" to the prerequisites; 2) change the effective date to Summer 2012 (201230). The reason for this is that the department would like to begin offering the course for the summer term, and this will allow them to use the number assigned, rather than offering it as a selected topics course.

In addition, the initiator of the proposals for Graphics Technology, Kristy Pennino, requested that the two courses approved at the January 11, 2012 meeting – GRA 1109 and GRA 2425 – be revised with regard to the effective date, for the same reason noted in the two courses above. This was approved by consensus, so those courses will also be effective Summer 2012 (201230); this will be noted in the January minutes as a revision.

1112-073 Graphics Technology with Specializations: Graphic Design and Interactive Design, A.S. Degree, CPMKristy Pennino

Purpose: 1) Change program name from "Graphics Technology" to instead be "Graphic & Interactive Design". This change is to provide clarity amongst current and prospective students regarding the program focus and to remove dated/redundant terminology (the term "technology" is a given and causes one to assume the program focus is merely on the technology used within the industry to execute visual solutions); 2) Add 4 new graphics courses to the pre-approved "Graphic Design Electives" list of courses (GRA 1109 History of Graphic Design, GRA 2225C Advanced Typography, GRA 2755C Web Development for Designers, GRA 2425 Business and Ethics of Graphic Design). These new courses give students more options to supplement their graphic design education while also providing more course transfer possibilities; 3) Allow Graphics AS Degree seekers to select either POS 2041 US Government or SPC 1017 Interpersonal Communication as a general education requirement. Graphics majors are already required to take a social science, meeting the social science general education requirement, and it has been determined Graphics graduates would benefit a GREAT deal from taking SPC 1017 Interpersonal Communication considering the degree to which the industry requires they use these skills (daily); **Effective Date:** Fall 2012 (201310).

Proposal 1112-073 was approved by consensus.

1112-076 GRA 1933C Fundamentals of Creative Thinking, CCMKristy Pennino

Purpose: A lab fee of \$46.00 (consistent with shared lab fees for all graphics courses college wide) is being added to this course due to its "C" designation (lab component); **Revised Lab Fees:** \$46.00 (previously, "None"); **Effective Date:** Fall 2012 (201310). 1112-081 OST 2466 Capstone Simulation for Coding, CCM Betty Wanielista
Purpose: This course fee was not changed when the other OST course fees were changed.
Needs to be \$23.00; **Revised Lab Fees:** \$23.00 (previously, \$34.00); **Effective Date:** Fall 2012 (201310).

1112-082 Hospitality – Food and Beverage Management, T.C., CPM Dan Dutkofski
Purpose: HUN 1004 will be added as an elective option for this Technical Certificate; **Effective Date:** Fall 2012 (201310).

1112-083 FSS 2055C Contemporary Cakes and Desserts, CCM Dan Dutkofski
Purpose: Adjustment of curriculum design; **Revised Prerequisites:** FSS 2061C (previously, FSS 2054C); **Revised Co-requisites:** None (previously, FSS 2054C); **Effective Date:** Fall 2012 (201310).

1112-084 FSS 2059C Chocolates and Confections, CCM Dan Dutkofski
Purpose: Adjustment of curriculum design; **Revised Prerequisites:** FSS 2058C (previously, FSS 2056C); **Effective Date:** Fall 2012 (201310).

Proposals 1112-083 and 1112-084 were approved by consensus.

1112-085 Chef's Apprentice, Technical Certificate, CPA Pierre Pilloud
Purpose: This program is designed for students interested in the culinary industry, focusing on the fundamental knowledge and skills one needs to work safely and efficiently in a culinary setting. Learners develop skills in sanitation and safety, recognition and identification of foods, proper storage of foods, methods of preparation, and food and beverage purchasing; **Effective Date:** Fall 2012 (201310).

Proposal 1112-085 was approved by consensus.

1112-086 Culinary Arts Management Operations, T.C., CPA Pierre Pilloud
Purpose: This program is designed for students interested in the culinary industry, focusing on the fundamental knowledge and skills one needs to work safely and efficiently in a culinary setting. Learners develop skills in sanitation and safety, recognition and identification of foods, proper storage of foods, methods of preparation, and food and beverage purchasing. They also examine the broad perspective of the culinary arts within the Hospitality field; **Effective Date:** Fall 2012 (201310).

Proposal 1112-086 was approved by consensus.

1112-087 SLS 1261 Leadership Development, CCM Christy Cheney
Purpose: This course is being updated to become an Honors course at Valencia; **Revised Official Course Number:** SLS 2261H (previously, SLS 1261); **Revised Official Course Title:** Leadership Development-Honors (previously, Leadership Development); **Revised Prerequisites:** Minimum grade of "C" in ENC 1101 or ENC 1101H or IDH 1110 (previously, "None"); **Revised Catalog Course Description:** This course will provide a basic understanding of leadership theory and group dynamics. Students will focus on leadership through the integration of readings in the humanities, contemporary case studies, film, experiential exercises, and group projects. Course content will satisfy one Honors Program learning outcome. Honors program permission required; **Effective Date:** Fall 2012 (201310).

Proposal 1112-087 was approved by consensus.

1112-088 SLS 2940 Service Learning, CCM..... Christie Pickeral
Purpose: This course needs to reflect the outcomes of a service-learning experience; **Revised Prerequisites:** Minimum 2.0 institutional or overall GPA; or department approval (previously, Satisfactory completion of all mandated courses in reading, math, English, and EAP; a minimum 2.0 institutional or overall GPA; and 12 credits. The Program Dir./Program Chair/Program Coordinator or IPO has the discretion to provide override approval as it relates to the waiver of required program/discipline-related courses); **Revised Catalog Course Description:** This course gives the student the opportunity to grow academically, pre-professionally, personally and civically through participation in a service-learning experience. Students meet real needs in the community by applying knowledge from their courses. Students complete 20 hours of service per credit, complete written reflections, and meet regularly with assigned faculty member. Multiple credit course. May be repeated for a maximum of 4 credits, but grade forgiveness cannot be applied; **Effective Date:** Fall 2012 (201310).

1112-089 SLS 2940H Service Learning-Honors, CCM Christie Pickeral
Purpose: This course needs to reflect the outcomes of a service learning experience and honors work; **Revised Prerequisites:** Minimum 2.0 institutional or overall GPA; or department approval (previously, Satisfactory completion of all mandated courses in reading, math, English, and EAP; a minimum 3.25 institutional or overall GPA; and 12 credits. Admission to the Honors Program required. The Program Dir./Program Chair/Program Coordinator or IPO has the discretion to provide override approval as it relates to the waiver of required program/discipline-related courses); **Effective Date:** Fall 2012 (201310).

Proposals 1112-088 and 1112-089 were approved by consensus.

1112-090 Honors Program, CPMValerie Burks
Purpose: In June of 2008, the CNL Charitable Foundation and the Valencia Community College Foundation entered an agreement to establish an endowment fund to support educational opportunities at the college. Part of the agreement was the renaming of the Valencia Honors Program to the James M. and Dayle L. Seneff Honors College. During the 2009-2010 academic years, a committee met several times and developed a blueprint for program revision. In the fall of 2010, the plan was presented to the College Learning Council, the Faculty Council, the

Instructional Affairs Committee, and other college groups whose mission directly impacts the proposed changes. On April 22, 2011, a college-wide honors summit was held to give shape to the final form of these ideas. The inaugural class of the James M. and Dayle L. Seneff Honors College will be admitted for academic year 2012-2013. The goal is to create an honors experience that builds on the strengths and flexibility of the present program, while providing purpose and meaning for students and faculty in the Seneff community; **Effective Date:** Fall 2012 (201310).

Proposal 1112-090 was approved by consensus.

1112-091 HUM 2461 Latin American Humanities, CCM Ana Caldero Figueroa
Purpose: Changes were made to Learning Outcomes. In addition, minor change to prerequisites and minor course revision; **Revised Prerequisites:** ENC 1101 or ENC 1101H or equivalent (previously, Minimum grade of "C" in ENC 1101 or ENC 1101H or IDH 1110); **Revised Catalog Course Description:** An integrated study of the history, culture, art, literature and music of Latin America. Focuses on how modern Latin American cultures are the product of a historic biological and cultural interchange between Europe, Africa, and the Americas. Topics include pre-Columbian civilizations, the Encounter and its aftermath, independence and neo-colonialism, and modernist art, literature, and cinema. Gordon Rule course in which the student is required to demonstrate college-level writing skills through multiple writing assignments. Minimum grade of C required if used to satisfy Gordon Rule requirement; **Effective Date:** Fall 2012 (201310).

Proposal 1112-091 was approved by consensus with the following revision: the prerequisites will remain as they were. The change proposed was a minor one and it was felt by the CCC that the original wording was clearer.

There was also some discussion about the fact that some portions of certain sections of this course are taught in Spanish. Discussion was mainly about how to communicate this to the students and ensure that only those students with a strong background in Spanish take those sections. After quite a bit of discussion, the issue was deferred to a later date, because there did not seem to be an easy solution to the Banner programming and thus communication to the students of this situation.

1112-092 EGN 3428 Engineering Mathematical Analysis, CCM..... Ali Notash
Purpose: Change in contact hours; **Revised Credit/Class (Lecture)/Lab Hours:** 3/4/0 (previously, 3/3/0); **Effective Date:** Fall 2012 (201310).

1112-093 EGN 3443 Statistical Theory for Engineering Technology, CCM Ali Notash
Purpose: Change in course description; **Revised Catalog Course Description:** This course encompasses topics of statistical methods and probability theory important for engineering technology students. Topics include organization and description of data, axioms and theorems of probability, conditional probability, probability distributions, Poisson processes, probability density functions, moment generating functions, statistics of populations and samples, estimation, test of hypotheses, regression analysis as applied to Engineering Technology. A

minimum grade of C is required if used to satisfy Electrical and Computer Engineering Technology, B.S. degree requirement; **Effective Date:** Fall 2012 (201310).

Proposal 1112-093 was approved by consensus.

1112-094 EET 3329C Communication Systems, CCM..... Ali Notash
Purpose: Modification of prerequisites; **Revised Prerequisites:** EET 2325C and EET 3086C (previously, EET 3086C); **Effective Date:** Fall 2012 (201310).

Proposal 1112-094 was approved by consensus.

1112-095 EET 4158C Linear Integrated Circuits and Systems, CCM..... Ali Notash
Purpose: Modification of prerequisites; **Revised Prerequisites:** EET 1141C and EET 3086C (previously, EET 3086C or EGN 3428); **Effective Date:** Fall 2012 (201310).

Proposal 1112-095 was approved by consensus.

1112-096 EET 4328 Wireless Communication, CCM Ali Notash
Purpose: Modification of prerequisites; **Revised Prerequisites:** EET 2325C and EET 3086C and EGN 3443 (previously, EET 3086C and EST 3340); **Effective Date:** Fall 2012 (201310).

Proposal 1112-096 was approved by consensus.

1112-097 EET 4359C Digital Communication, CCM..... Ali Notash
Purpose: Modification of prerequisites; **Revised Prerequisites:** EET 2325C and EET 3086C and EGN 3443 (previously, EET 3086C and EST 3340); **Effective Date:** Fall 2012 (201310).

Proposal 1112-097 was approved by consensus.

1112-098 EET 4950 Senior Project Design, CCM..... Ali Notash
Purpose: Revision in Official Course Title to fix error; **Revised Official Course Title:** Senior Design Project (previously, Senior Project Design); **Effective Date:** Fall 2012 (201310).

1112-099 *EST 4256C Optical Communication Systems, CCM Ali Notash
Purpose: Modification of prerequisites; **Revised Prerequisites:** EST 1210C or EST 2220C or PHY 2049C and EGN 3428 (previously, EST 2220C or PHY 2049C and EGN 3428); **Effective Date:** Fall 2012 (201310).

1112-100 ETI 3116 Quality Assurance and Testing Methods, CCM..... Ali Notash
Purpose: Modification of prerequisites; **Revised Prerequisites:** Minimum grade of C in MAC 2312 (previously, EET 3086C); **Effective Date:** Fall 2012 (201310).

1112-101 ETP 4240C Power Electronics, CCM Ali Notash
Purpose: Modification of prerequisites; **Revised Prerequisites:** EET 4158C (previously, ETP 4241); **Effective Date:** Fall 2012 (201310).

1112-102 CET 4126C Microprocessor Programming, CCM Ali Notash
Purpose: Modification of prerequisites; **Revised Prerequisites:** CET 2113C and CET 2123C and COP 3275 (previously, CET 2113C and CET 2123C); **Effective Date:** Fall 2012 (201310).

Proposal 1112-102 was approved by consensus.

1112-103 CET 4333 Computer Architecture, CCM Ali Notash
Purpose: Modification of prerequisites; **Revised Prerequisites:** CET 2113C and CET 2123C (previously, CET 4126C); **Effective Date:** Fall 2012 (201310).

Proposal 1112-103 was approved by consensus.

1112-104 CET 4367C Microcontroller Devices, CCM Ali Notash
Purpose: Modification of prerequisites; **Revised Prerequisites:** CET 2113C and CET 2123C (previously, EET 1141C and EET 3086C); **Effective Date:** Fall 2012 (201310).

Proposal 1112-104 was approved by consensus.

1112-105 CET 4382 Data Communication and Networking, CCM..... Ali Notash
Purpose: Modification of prerequisites; **Revised Prerequisites:** EET 2325C and EGN 3428 (previously, CET 4333); **Effective Date:** Fall 2012 (201310).

Proposal 1112-105 was approved by consensus.

There was some discussion regarding the lack of “minimum grade of C . . .” requirement for prerequisites in the B.S. degree program courses. Karen Borglum recalled that the minimum grade issue had been discussed and resolved when the B.S. program was originally approved. It had been decided that each course description would end with verbiage that a minimum grade of C is required if the course will be used to satisfy the requirements of the Bachelor’s program. It had also been determined that they could not require lower level (1000 and 2000) courses to have been completed with a minimum grade of C, since that is not a requirement for the A.S. degree programs; and, the entire programs as a “package” are what is accepted for entrance into the B.S. program.

The discussion went on for a while without full resolution, and it was decided that the topic will be revisited at a later date.

1112-106 FIN 2051 International Finance, CCA.....Barry Bunn
Purpose: This course will become part of the new International Business specialization; **Catalog Course Description:** This course is designed for the student to learn the basic concepts and principles of international finance, with consideration of the financial environment, transactions, and flows. Exchange rates, risks, and government policies affecting business are analyzed as well as management policies and decisions; **Prerequisites:** GEB 1350; **Co-requisites:** None; **Credit/Class (Lecture)/Lab Hours:** 3/3/0; **Effective Date:** Fall 2012 (201310).

*Proposal 1112-106 was approved by consensus with the following prerequisite revision:
"Minimum grade of C" will be added.*

1112-107 MAR 2150 International Marketing, CCA.....Barry Bunn
Purpose: This course will become part of the new International Business specialization; **Catalog Course Description:** This course examines marketing concepts and strategies as applied to global markets. Students will explore the implications of organizing people, process, and technology given the influences of ideas, culture, laws, and economics. The course is intended to be more hands-on, although students will use a combination of text, lectures, case studies, outside reading, company research, video, group work, and presentation to enhance learning and practicing skills; **Prerequisites:** GEB 1350; **Co-requisites:** None; **Credit/Class (Lecture)/Lab Hours:** 3/3/0; **Effective Date:** Fall 2012 (201310).

*Proposal 1112-107 was approved by consensus with the following prerequisite revision:
"Minimum grade of C" will be added.*

1112-108 GEB 1350 Introduction to International Business, CCMBarry Bunn
Purpose: To update description to meet today's global environment. This course will be part of a new specialization entitled International Business. Course outcomes and competencies were also changed; **Revised Catalog Course Description:** This course is an entry-level overview of current world trade activities, practices, and issues. (Special Fee: \$36.00); **Prerequisites:** Minimum grades of C in DIG 2100C and either DIG 2000C or GRA 1142C; or department approval; **Co-requisites:** None; **Credit/Class (Lecture)/Lab Hours:** 3/2/1; **Effective Date:** Fall 2012 (201310).

1112-161 DIG 2561C Project Management for Digital Media, CCA.....Robert McCaffrey
Purpose: This is a new course for the proposed Web Development track; **Catalog Course**
Description: This course covers planning and managing the creative and technical requirements of a web or multimedia project. Topics include project scheduling, budgeting, tracking, and reporting. (Special Fee: \$36.00); **Prerequisites:** Minimum grade of C in DIG 2106C or DIG 2107C; or department approval; **Co-requisites:** None; **Credit/Class (Lecture)/Lab Hours:** 3/2/1; **Effective Date:** Fall 2012 (201310).

1112-162 DIG 2312C Introduction to ActionScript, CCA.....Robert McCaffrey
Purpose: This is a new course for the proposed Web Development track; **Catalog Course**
Description: Reinforces basic programming concepts inside the Adobe Flash environment. Students will learn the basics of the Flash interface along with beginning to intermediate level coding inside ActionScript. (Special Fee: \$53.00); **Prerequisites:** Minimum grades of C in DIG 1102C and DIG 1940; or department approval; **Co-requisites:** None; **Credit/Class (Lecture)/Lab Hours:** 3/3/1; **Effective Date:** Fall 2012 (201310).

1112-166 DIG 2431C Advanced Digital Storytelling, CCARobert McCaffrey
Purpose: As part of an ongoing review of program effectiveness, this course is being added to give students an option to study storytelling at a deeper level and to increase flexibility in the digital media course flows; **Catalog Course Description:** Students create purpose-driven narratives utilizing industry-standard software. (Special Fee: \$70.00); **Prerequisites:** Minimum grade of C in DIG 2430C; or department approval; **Co-requisites:** None; **Credit/Class (Lecture)/Lab Hours:** 3/2/1; **Effective Date:** Fall 2012 (201310).

Proposals 1112-164 through 1112-166 were approved by consensus.

1112-167 DIG 2941 Internship Exploration in Digital Media, CCARobert McCaffrey
Purpose: This class is intended to give students early in the program and in programs outside the DIG area the opportunity to explore a workplace in the digital media industry; **Catalog Course Description:** This course is a planned work-based experience that provides students with supervised career exploration activities and/or practical experiences to assist in confirming their educational plans. Each earned credit of Internship requires a minimum of 80 clock hours of work. Multiple credit course. May be repeated for credit, but grade forgiveness cannot be applied. (Internship Fee: \$10.00); **Prerequisites:** Satisfactory completion of all mandated courses in reading, math, English, & EAP; 2.0 institutional or overall GPA; 12 credits, including a minimum grade of C in DIG 2000C; or Program Chair approval; **Co-requisites:** None; **Credit/Class (Lecture)/Lab Hours:** 1-4/Var./0; **Effective Date:** Fall 2012 (201310).

Proposal 1112-167 was approved by consensus, with the following minor revisions: 1) course description will be revised to state the maximum number of hours the course can be repeated for credit (4); 2) the prerequisites will be revised to reflect the standardized wording approved for all internship exploration courses.

1112-168 DIG Var Various Digital Media Courses, CCM.....Robert McCaffrey
Purpose: Based on an ongoing review of lab cost, student use, and the addition of new courses with labs, this modification accounts for the changes in every DIG course with a lab component;
Effective Date: Fall 2012 (201310).

1112-169 DIG 2030C Digital Video and Sound, CCM.....Robert McCaffrey
Purpose: These changes are part of an ongoing review of program effectiveness. Students are learning sufficient image manipulation in DIG 2000C to be successful in DIG 2030C. The writing competencies in DIG 2430C will be better utilized in DIG 2284C; **Revised Prerequisites:** Minimum grade of C in DIG 2000C or GRA 1142C; or department approval (previously, Min. grade of C in GRA 2201C or both DIG 2430C and DIG 2109C or department approval); **Effective Date:** Fall 2012 (201310).

Purpose: As part of an ongoing review of program effectiveness, DIG 2430C becomes a pre-req for this course. Additionally, this removes MUM 2630C as a pre-req so that students in the new Mobile Journalism track may take DIG 2284C; **Revised Prerequisites:** Minimum grades of C in DIG 2030C and DIG 2430C; or department approval (previously, Min. grade of C in DIG 2030C and MUM 2630C or department approval); **Effective Date:** Fall 2012 (201310).

1112-171 DIG 2291C Advanced Audio Visual Technology, CCM.....Robert McCaffrey
Purpose: We are adding TPA 2290C as a prerequisite to allow students in Entertainment Technology a pathway to the Advanced AV course; **Revised Prerequisites:** Minimum grades of C in TPA 2257 and either DIG 2284C or TPA 2290C; or department approval (previously, Minimum grades of C in DIG 2284C and TPA 2257; or department approval); **Effective Date:** Fall 2012 (201310).

1112-172 DIG 2302C Introduction to 3D Motion Graphics, CCM.....Robert McCaffrey
Purpose: As part of an ongoing review of program effectiveness, we are dropping a video production pre-requisite and adding an animation pre-requisite to this course; **Revised Prerequisites:** Minimum grades of C in GRA 2156C and either DIG 2341C or GRA 2160; or department approval (previously, Min. grade of C in DIG 2030C and GRA 2156C or department approval); **Effective Date:** Fall 2012 (201310).

RE: PROPERTY DELETIONS

Surplus, trade-in, obsolete, economically unrepairable, or missing equipment items are periodically deleted from the property records of the College. Equipment which is surplus, obsolete or not economically repairable may be donated to local school systems, non-profit organizations or other governmental entities.

Per Florida Statute 274.02, equipment with a cost or fair market value of \$1,000 or more and a projected useful life of more than one year must be recorded in the financial records as property for inventory purposes. Therefore, original cost reflects the cost of the item at the date of acquisition, or the estimated fair market value at the date received, in the case of gifts.

Equipment is depreciated on a straight-line basis over the following estimated useful lives:

- Computers – three years
- Vehicles, office machines, educational equipment – five years
- Furniture – seven years

Therefore, current book value reflects the net depreciated value (acquisition cost or fair market value less depreciation).

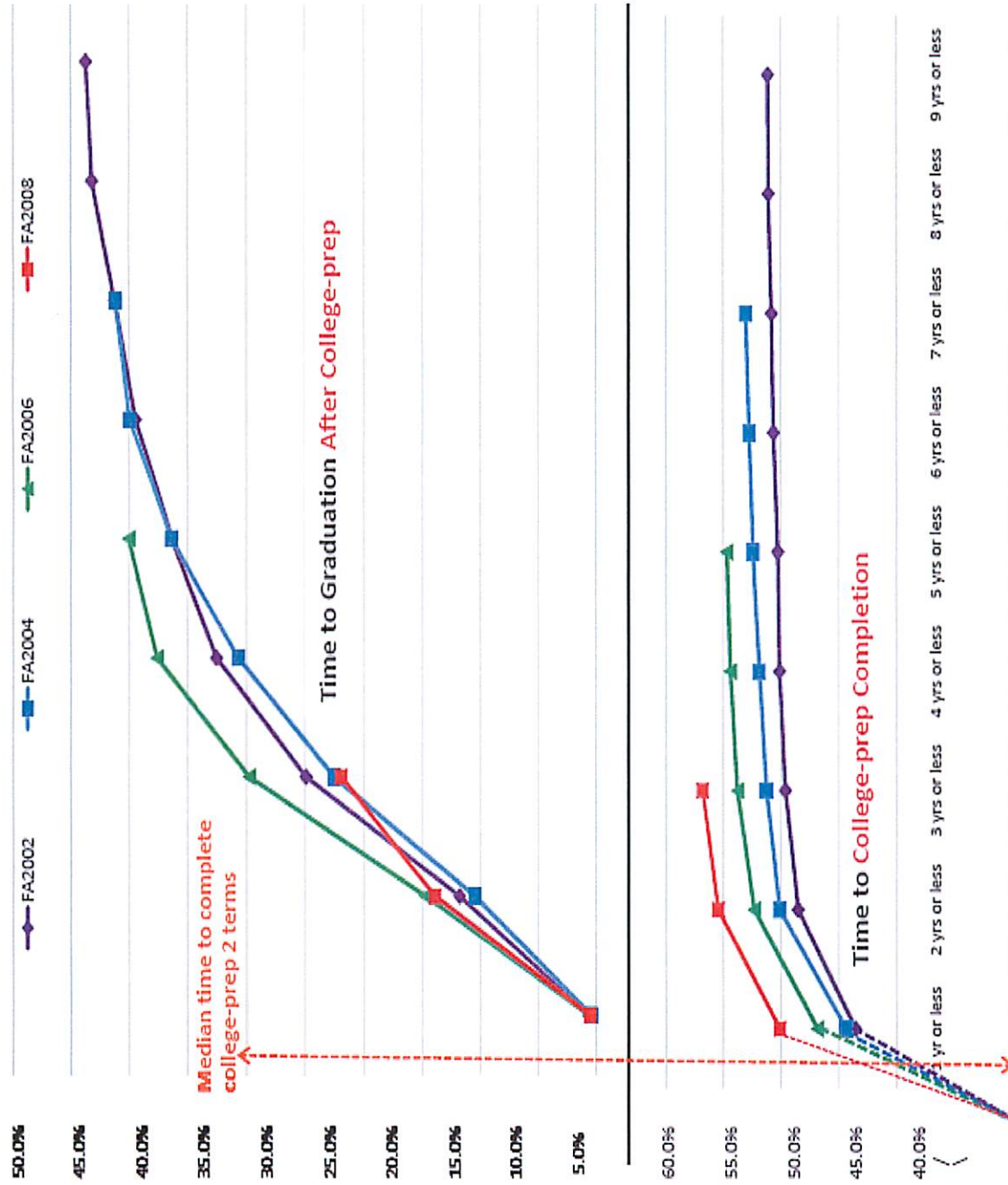

Osceola Campus – Building 4

The roof and windows are being installed. Precast is being erected. Interior walls are being framed on all floors, along with mechanical equipment and ductwork. Fire sprinkler lines and electrical cables are being run. Plumbing is being roughed in.

The Central Energy Plant was completed and started operations at the end of March.

Lake Nona Campus – Building 1

Main building: The interior wall framing is completed. All stairs are installed and the elevator will be completed in approximately two weeks. All roofing is finished except the metal panels, which will be completed by mid-April. Curtain wall framing is complete. Glazing has begun. Brick and stone veneer is scheduled for completion by May.

The Central Energy Plant is nearly complete.

Construction is on schedule for completion in July 2012. Installation of technology and furniture will take five weeks. Classes begin August 27, 2012.

West Campus - Building 10

Foundation and underground utilities are done. First floor slab is poured. Precast panels and structural steel at the first floor are completed. Hollow core slab and topping for the second floor is complete. The second floor precast panels are completed.
