At the September 18, 2012, Board meeting, the Board of Trustees approved Arellano Construction as Construction Manager at Risk for the above referenced project. On January 22, Arellano Construction submitted a guaranteed maximum price of \$2,399,852 for the renovation of approximately 31,600 square feet in the Student Services Building on the West Campus, which is just below the construction budget of \$2.4 million.

RECOMMENDED ACTION:

The President recommends the Board of Trustees of Valencia College, after input from the Board, enter into a Guaranteed Maximum Price Contract for Construction Manager at Risk with Arellano Construction. The total Guaranteed Maximum price is \$2,399,852.

The Consent Agenda was approved by consensus.

4. Regular Agenda

1213-006 ARA 1120 Elementary Arabic I, CCA.....Lester Sandres

Purpose: The purpose is to introduce students to the experience of learning a foreign language. Through the study of Arabic and foreign languages, students develop their ability to communicate in a global context and appreciate foreign cultures; **Catalog Course Description:** For students without two years of recent high school Arabic completed within the last three years or department approval. An introduction to written and spoken Modern Standard Arabic (MSA). Emphasis on Modern Standard Arabic (MSA) alphabet, use of the language, integrating basic grammar, vocabulary, composition and culture through a conversational approach to Arabic. Not open to native speakers. A minimum grade of C is required to pass this course if being used to satisfy the General Education Foreign Language requirement; **Prerequisites:** None; **Co-requisites:** None; **Credit/Class (Lecture)/Lab Hours:** 4/4/0; **Effective Date:** Spring 2013 (201320).

There was some discussion about changes that need to be made to the wording of the catalog course description. The words "General Education Foreign Language requirement" needs to be changed to "Foreign Language Proficiency." Also, the effective date needs to be changed to: Fall 2013. A Credit Program Modification needs to be done since this course can lead to foreign language proficiency.

Proposal 1213-006 was approved by consensus with the above changes.

1213-007 ARA 1121 Elementary Arabic II, CCA.....Lester Sandres

Purpose: The purpose is to introduce students to the experience of learning a foreign language. Through the study of Arabic and foreign languages, students develop their ability to communicate in a global context and appreciate foreign cultures; **Catalog Course Description:** Continuation of the Modern Standard Arabic, developing, speaking, reading, and writing skills. Use of Arabic is emphasized throughout course focusing on increasing vocabulary and grammatical skills. Fundamental skills in Arabic comprehension, expression, and structure. Increasing awareness and understanding of the culture. Not open to native speakers. A minimum grade of C is required to pass this course if being used to satisfy the General Education Foreign Language Proficiency Requirement; **Prerequisites:** Min. grade of C in ARA 1120 or equivalent (ARA 1100 or two years of high school Arabic completed within the last three years and department approval); **Co-requisites:** None; **Credit/Class (Lecture)/Lab Hours:** 4/4/0; **Effective Date:** Spring 2013 (201320).

There was some discussion about changes that need to be made to the wording of the catalog course description. The words "General Education Foreign Language Proficiency Requirement" needs to be changed to "Foreign Language Proficiency." The prerequisite of ARA 1100 needs to be omitted and the effective date needs to be changed to: Fall 2013. A Credit Program Modification needs to be done since this course can lead to foreign language proficiency.

Proposal 1213-007 was approved by consensus with the above changes.

1213-008 CJK 0294 Correctional Cross-Over to Law Enforcement Patrol 2, CCA

Purpose: This is a state-mandated change to the program curriculum; **Catalog Course Description:** This course provides the student with the skills to respond to hazardous materials incidents, bomb threats, building evacuations and weapons of mass destruction. The students are introduced to the existence and activities of criminal gangs and extremist groups; **Prerequisites:** None; **Co-requisites:** None; **PSAV/Contact:** .667/20/0; **Effective Date:** Spring 2013 (201320).

1213-009 CJK 0295 Correctional Cross-Over to Law Enforcement Officer Wellness, CCA

Purpose: This is a state-mandated change to the program curriculum; **Catalog Course Description:** This course will prepare recruits to understand the physical demands of the duties of a law enforcement officer. They will be given information on developing a healthy lifestyle and personal fitness regimen; **Prerequisites:** None; **Co-requisites:** None; **PSAV/Contact:** 1.167/35/0; **Effective Date:** Spring 2013 (201320).

Proposal 1213-009 was approved by consensus.

1213-010 CJK 0392 Cross-Over Handgun Transition Course, CCA.....Jeff Goltz

Purpose: This is a state-mandated change to the program curriculum; **Catalog Course Description:** This course provides training and transitions a student from the use of a semiautomatic handgun to a revolver, or vice versa; **Prerequisites:** None; **Co-requisites:** None; **PSAV/Contact:** .8/24/0; **Effective Date:** Spring 2013 (201320).

Proposal 1213-010 was approved by consensus.

1213-011 CJK 0393 Cross-Over Program Updates, CCA.....Jeff Goltz

Purpose: This is a state-mandated change to the program curriculum; **Catalog Course Description:** This course is for instructors to deliver expanded or updated instruction on curriculum topics contained in this cross-over program, e.g., new techniques, high liability area or application of relevant case law; **Prerequisites:** None; **Co-requisites:** None; **PSAV/Contact:** .267/8/0; **Effective Date:** Spring 2013 (201320).

Proposal 1213-011 was approved by consensus.

1213-012 CJK 0221 Correctional Cross-Over to Law Enforcement Introduction and Legal, CCM.....Jeff Goltz
Purpose: This is a state-mandated curriculum change; **Revised Course Prefix and Number:** CJK 0290;
Revised Course Title: Correctional Cross-Over to Law Enforcement Introduction and Legal Overview;
PSAV/Contact: 1.6/48/0; **Effective Date:** Spring 2013 (201320).

Proposal 1213-012 was approved by consensus.

1213-013 CJK 0222 Correctional Cross-Over to Law Enforcement Communications, CCM.....Jeff Goltz
Purpose: This is a state-mandated curriculum change; **Revised Course Prefix and Number:** CJK 0291;
Revised Course Title: Correctional Cross-Over to Law Enforcement Human Interaction and Communications; **Effective Date:** Spring 2013 (201320).

Proposal 1213-013 was approved by consensus.

1213-014 CJK 0223 Correctional Cross-Over to Law Enforcement Human Issues, CCM.....Jeff Goltz
Purpose: This is a state-mandated curriculum change; **Revised Course Prefix and Number:** CJK 0292;
Revised Course Title: Correctional Cross-Over to Law Enforcement Response to Human Issues;
PSAV/Contact: 0.8/24/0; **Effective Date:** Spring 2013 (201320).

Proposal 1213-014 was approved by consensus.

1213-015 Crossover: Corrections to Law Enforcement, CPM Jeff Goltz
Purpose: The Florida Department of Law Enforcement mandated a curriculum change to this certification program effective July 1, 2012; **Revised Program Title:** Correctional Officer Cross-Over to Law Enforcement Basic Recruit Training; **Effective Date:** Spring 2014 (201420).

Proposal 1213-015 was approved by consensus.

1213-016 HLP 2550C Concepts of Personal Training, CCA.....Tammy Sabourin
Purpose: To provide an opportunity for our students to complete a course to prepare them to get certified as a personal trainer from a national accredited organization; **Catalog Course Description** This course is designed to prepare students for the National Council on Strength and Fitness (NCSF) Certified Personal Training Exam. Students will learn goal-specific program design and gain the knowledge to assess, motivate, educate and train clients regarding their health and fitness needs. This class also provides hands on practical experience in a fitness setting. Completion of the NCSF personal training certification exam is optional. (Special Fee: \$20.00); **Prerequisites:** None; **Co-requisites:** None; **Credit/Class (Lecture)/Lab Hours:** 3/2/2; **Effective Date:** Spring 2013 (201320).

Due to some changes and items needed, this course was tabled until January 2013. A lab form needs to be submitted. The catalog course description needs to state that this course is not repeatable for credit and also the language that mentions the personal training certification exam needs to be omitted from the catalog course description.

Proposal 1213-016 was tabled until January, 2013.

1213-017 IDH 2911 Honors Research Process, CCA.....Keith Malmos

Purpose: The new Undergraduate Research Track of the new James M and Dayle L. Seneff Honors College has two track specific courses. This course is preparatory to conduct and present research. A new course is essential at Valencia College for students to obtain this experience; **Catalog Course Description:** This honors course will introduce students to the process of research, tools, concepts, and resources necessary to search, evaluate, and use information in a variety of formats and subject disciplines. The focus will be to analyze and utilize information critically using a broad range of materials and interdisciplinary concepts needed for honors research and academic/professional success; **Prerequisites:** Admission to the James M and Dayle L. Seneff Honors College and grade of 'C' or better in ENC1101 or ENC 1101H or IDH 1110; **Co-requisites:** None; **Credit/Class (Lecture)/Lab Hours:** 2/2/0; **Effective Date:** Spring 2013 (201320).

Proposal 1213-017 was approved by consensus.

1213-018 MAT 0055 Developmental Mathematics Module I, CCA.....Russell Takashima

Purpose: The course was developed by the State, SCNS MAT 0055, to provide an alternative for students to progress to college-level math while reducing the number of developmental math classes required. Students will have the opportunity to complete specific MAT0055 topic modules as assigned after the completion of the PERT math diagnostic. Students will be able to complete MAT0055 and MAT1033-Intermediate Algebra in the same term; **Catalog Course Description:** This course provides specialized instruction in developmental mathematics concepts to prepare students for MAT 1033, Intermediate Algebra. Topics include fundamental operations on polynomials, linear equations and inequalities with applications, factoring and its use in algebra, introduction to graphing linear equations, introduction to radicals and rational expressions. Upon completion of the P.E.R.T. diagnostic or a Mathematics division diagnostic, students will be assigned one or two topic modules. Students must complete each module with a grade of C. This course does not apply toward mathematics requirements in general education or toward any associate degree; **Prerequisites:** Minimum grade of C in MAT 0018C or appropriate score on approved assessment or permission of the Mathematics division program coordinator; **Co-requisites:** None; **Credit/Class (Lecture)/Lab Hours:** 1/1/0; **Effective Date:** Spring 2013 (201320).

It was agreed upon that instead of a minimum grade of C in MAT 0018, the prerequisite should read: "Score of 110-112 on PERT and department approval." A CCM will need to be done for MAT 1033C to add the following as prerequisites: "MAT 0055 or MAT 0056." This will be brought for approval to the January 2013 meeting.

Proposal 1213-018 was approved by consensus with the above changes.

1213-019 MAT 0056 Developmental Mathematics Module II, CCA.....Russell Takashima

Purpose: The course was developed by the State, SCNS MAT0056, to provide an alternative for students to progress to college-level math while reducing the number of developmental math classes required. Students will have the opportunity to complete specific MAT0056 topic modules as assigned after the completion of the PERT math diagnostic. Students will be able to complete MAT0056 and MAT1033-Intermediate Algebra in the same term; **Catalog Course Description:** This course provides specialized instruction in developmental mathematics concepts to prepare students for MAT1033 Intermediate Algebra. Topic modules include fundamental operations on polynomials, linear equations and inequalities with applications, factoring and its use in algebra, introduction to graphing linear equations, introduction to radicals and rational expressions.

Upon completion of the P.E.R.T. diagnostic or a Mathematics division diagnostic, students will be assigned three or four major topic modules. Students must complete each module with a grade of C or better. This course does not apply toward mathematics requirements in general education or toward any associate degree; **Prerequisites:** Minimum grade of C in MAT 0018C or appropriate score on approved assessment or permission of the Mathematics division program coordinator; **Co-requisites:** None; **Credit/Class (Lecture)/Lab Hours:** 2/2/0; **Effective Date:** Spring 2013 (201320).

It was agreed upon that instead of a minimum grade of C in MAT 0018, the prerequisite should read: "Score of 110-112 on PERT and department approval." The credit/class/lab hours were changed to 2/2/0. A CCM will need to be done for MAT 1033C to add the following as prerequisites: "MAT 0055 or MAT 0056." This will be brought for approval to the January 2013 meeting.

Proposal 1213-019 was approved by consensus with the above changes.

1213-020 SPN 1001 Conversational Spanish II, CCA.....Ana Caldero

Purpose: This course is a continuation of SPN 1000, Conversational Spanish; **Catalog Course**

Description: Conversational Spanish II is a communicative based course and a continuation of Conversational Spanish I. Students will continue learning basic language skills necessary for practical daily applications in different social settings. Conversation will be enhanced using speaking, listening, reading and writing skills. This course will be taught utilizing a variety of multisensory techniques that foster the development of oral proficiency in Spanish. This course does not satisfy the college foreign language requirements and is not open to native speakers; **Prerequisites:** SPN 1000; or department approval; **Co-requisites:** None; **Credit/Class (Lecture)/Lab Hours:** 3/3/0; **Effective Date:** Spring 2013 (201320).

Instead of "foreign language requirements" in the catalog course description, it needs to read: "foreign language proficiency requirement."

Proposal 1213-020 was approved by consensus with the above change.

5. Discussion Items

- **Courses for Provisional Students** – During the October meeting, Karen Borglum requested that the committee members review the list of courses, by department, in order to see if any courses on the list should be removed or if any courses not on the list should be added. Committee members were asked to bring their recommendations to the November meeting.

Melody Boeringer submitted CHM 1020 to be added to the Provisional Course List. Karen asked that the committee members take some more time to go through the list, by department, and submit their recommendations to her by the end of the Fall semester. She will re-construct the list and bring it the January meeting for a vote.

- **Course Substitution Lists** – As co-chair of the Course Substitution Committee, Karen Borglum is requesting a review of the courses that are currently available for Mathematics and Foreign Language substitutions, to determine if they should remain on or be deleted from the list. The lists were discussed at the November 2 Course Substitution meeting, and Karen will share the results of that meeting.

On November 2nd there was a discussion among the Course Substitution Committee members regarding what courses should stay on the list and what courses should be removed. Karen announced that she will ask the advisors to go through the lists and make recommendations. We will continue with the current list until Fall 2013. She will bring the changes back to the Curriculum Committee by Summer.

- **General Education Steering Committee update** – Karen Borglum will present an update on the progress of the State’s General Education Steering Committee, with regard to House Bill 7135. She will brief the CCC on the recent Steering Committee meeting that took place on October 25 in Tampa.

Karen reminded the committee members that there was still a lot of work going on with regards to HB 7135. She talked about the invitation in the Grove that encourages faculty to participate in the discussions happening on November 30th. She stated that there are three areas that have come up with core courses that they will recommend to faculty, and the other two areas are still working on their core courses. Karen and John Niss reiterated the importance of faculty getting involved in these meetings, even if it is not their discipline.

6. Information Items

There were no information items this month.

The next meeting of the College Curriculum Committee is scheduled for January 9, 2012, and will be held on the East Campus, Room 3-113. The deadline for submission of agenda items and related materials for the December meeting is *December 12 (*agenda items will not be accepted after that date).

Surplus, trade-in, obsolete, economically unrepairable, or missing equipment items are periodically deleted from the property records of the College. Equipment which is surplus, obsolete or not economically repairable may be donated to local school systems, non-profit organizations or other governmental entities (see attached list). The remainder of the items are disposed of through recyclers or to trash, depending on the type of equipment. All electronic equipment is disposed of through recyclers.

For your information, we have also attached a list of organizations that have benefited from equipment the college has disposed of in recent months.

Per Florida Statute 274.02, equipment with a cost or fair market value of \$1,000 or more and a projected useful life of more than one year must be recorded in the financial records as property for inventory purposes. Therefore, original cost reflects the cost of the item at the date of acquisition, or the estimated fair market value at the date received, in the case of gifts.

Equipment is depreciated on a straight-line basis over the following estimated useful lives:

- Computers – three years
- Vehicles, office machines, educational equipment – five years
- Furniture – seven years

Therefore, current book value reflects the net depreciated value (acquisition cost or fair market value less depreciation).


