RE: AWARD OF ITB # 2016-70 FOR INSTALLATION SERVICES CHILLER

EXPANSION EAST CAMPUS

On April 8, 2016, the College issued ITB # 2016-70, for Installation Services Chiller Expansion East Campus. The solicitation was for providing general contracting services to install owner-furnished chiller units to expand the East Campus Chiller Plant Building.

A non-mandatory pre-bid meeting was held on Tuesday, April 19, 2016. Bids were opened on Wednesday, May 18, 2016. Three (3) bidders responded to the solicitation:

- 1. Amsco
- 2. Gibson Air Conditioning & Refrigeration, LLC DBA Gibson Air Mechanical (Bid withdrawn)
- 3. Tri M Mechanical Services

The bids were evaluated based on total price to provide labor, equipment and materials for a turn-key installation. Tri – M Mechanical Services is the lowest, responsive and responsible bidder.
