

**Articulation Agreement
Between
Valencia Community College
and
Webster University**

This agreement is entered into this ____ day of _____, 1993, by and between the District Board of Trustees of Valencia Community College, hereinafter referred to as "Valencia," and the Board of Trustees of the Webster University, hereinafter referred to as "Webster."

WHEREAS, Valencia and Webster desire to coordinate curricula so students may move easily from the last Valencia course in a sequence to the next course in a program at Webster.

WHEREAS, Valencia and Webster desire the effective use of their resources to provide those seeking higher education with a wider range of options in achieving their educational goals.

WHEREAS, the most important reason for this document is to facilitate the transfer of students from Valencia, in particular at the time of their completion of the Associate in Arts or Associate in Science programs, to a Bachelor's degree program at Webster.

WHEREAS, it is hoped that the agreement will stimulate communication and interchange between the faculties of the two institutions and thus enhance the educational quality of both institutions.

WHEREAS, the cooperation and coordination outlined in this agreement will be an ongoing, continuous process which will be further defined and amplified over time.

NOW, THEREFORE, the parties agree to cooperate in the following ways to articulate programs so that students may take full advantage of educational opportunities best suited to their individual needs.

ARTICLE I. General Conditions of the Agreement: During the period of this agreement, Webster will agree to the following terms relative to Valencia students seeking transfer:

- (A) Valencia students who have earned the Associate in Arts or Associate in Science degrees are eligible to transfer up to 64 credit hours to Webster. Webster recognizes both the AA and AS degrees as completion of general education requirements and guarantees the recipient entry into Webster as a junior.
- (B) Students must have a cumulative G.P.A. of 2.5.
- (C) Webster accepts credits earned through standardized exams such as CLEP, ACT-PEP, DANTES, USAFI, etc. Webster also follows the credit recommendations of the American Council on Education (ACE) for various corporate and military training programs.

(D) Transfer students are required to complete a 9 credit hour liberal arts component for residential credit as part of their upper division Bachelor of Arts (B.A.) Degree program at Webster.

(E) The following courses can be taken at Valencia as part of the 64 transferable hours and will count toward the Webster General Business Core:

- 1) BUS 101 Financial Accounting (Valencia equivalent ACG 2021 Principles of Financial Accounting).
- 2) BUS 102 Managerial Accounting (Valencia equivalent ACG 2071 Principles of Managerial Accounting).
- 3) ECO 201 Macroeconomics (Valencia equivalent ECO 2013 Principles of Economics - Macro).
- 4) ECO 202 Microeconomics (Valencia equivalent ECO 1023 Principles of Economics - Micro).
- 5) MGT 210 Management Theory and Practices (Valencia equivalent MAN 2021 Principles of Management).
- 6) MGT 329 Business Law I (Valencia equivalent BUL 2111 Business Law I).
- 7) MGT 330 Business Law II (Valencia equivalent BUL 2212 Business Law II).
- 8) MGT 350 Marketing (Valencia equivalent MAR 2011 Principles of Marketing).
- 9) LLN 209 Writing for Business (Valencia equivalents OST 1335 Business Communication or ENC 1210 Technical Writing).

(F) The following courses can be taken at Valencia as part of the 64 transferable hours and will count toward the Webster Computer Science core:

- 1) CST 143 Introduction to Information Processing (Valencia equivalent CGS 1000 Introduction to Data Processing)
- 2) CST 155 Computer Programming I (Valencia equivalent COP 1000 Programming I)
- 3) CST 157 Mathematics for Computer Science I (Valencia equivalent MAS 2103 Introduction to Matrices)

- (G) Beginning with the 1993-94 Webster catalog, the Webster catalog in effect at the time of the student's initial enrollment at Valencia shall govern the Webster graduation requirements.
- (H) Webster accepts as transfer credit work completed with a grade of "C" or better. A maximum of five "D" grades, not to exceed 15 semester credit hours, may be counted toward the degree requirements at Webster. The "D" grade transfer policy is subject to change should circumstances warrant.
- (I) Valencia students with an Associate in Arts or Associate in Science degrees will be given special consideration for all Webster scholarships.

ARTICLE II. Academic Rules and Regulations: Unless stated otherwise in this agreement all academic rules and requirements stated in the applicable Webster University catalog will apply.

ARTICLE III. Obligations of Valencia: During the period of this agreement with Webster University, Valencia will agree to the following:

- (A) The Articulation Agreement between Valencia and Webster will be publicized among the faculty and students.
- (B) Information on the recommended core requirements of Webster will be made available to all interested Valencia faculty, counselors, and students.
- (C) Valencia will cooperate with Webster admissions personnel to have conferences with students who are interested in transferring to Webster.

ARTICLE IV. Equal Opportunity: The parties agree to provide equal enrollment opportunities to all persons regardless of race, color, religion, sex, age, national origin, disability or marital status during the term of this agreement, implementing the rules and regulations prescribed by the Florida Commission on Human Rights.

ARTICLE V. Third Party Obligations: This Agreement is made solely for the benefit of the parties thereto, and is not intended to create third party beneficiaries.

ARTICLE VI. Applicable Law: This Agreement shall be governed by and construed in accordance with the laws of the State of Florida and the rules of the State Board of Education.

ARTICLE VII. Parties Bound: This Agreement shall apply to and bind the parties hereto, together with their respective heirs, successors and assigns.

ARTICLE VIII. Total Agreement: This Agreement shall supersede all other proposals and negotiations with regard to the transfer of AA and AS students and shall constitute the foundation Agreement for AA and AS degree student transfer from Valencia Community College into the Webster University General Business program. Individual programmatic articulation agreements may be developed that specify course equivalents for the five Baccalaureate degrees offered by Webster: Bachelor of Arts in Management (without an emphasis), Management with an emphasis in Business Administration, Management with an emphasis in Human Resource Management and Management with an emphasis in Marketing; and a Bachelor of Science in Computer Science. The programmatic articulation agreements require only the signatures of the respective Webster and Valencia department chairs.

ARTICLE IX. Modifications: Any modifications, additions, or deletions from this Agreement must be in writing and signed by both parties. The designated representatives are the Director of the Webster University, Orlando Metropolitan Campus and the Valencia Articulation Officer.

ARTICLE X. Term of This Agreement: This Agreement shall be continuous from the date first shown on page one of this Agreement. Both parties shall meet for a review of this Agreement four years after its inception. Either party may terminate this Agreement at any time upon ninety (90) days written notice to the other party, provided the termination shall not become effective until after the current term has been completed.

**ADDENDA TO ARTICULATION AGREEMENT

The following paragraph is added to Section I of the basic agreement and becomes effective on the date when both parties have executed this Addenda.


- L. International students receiving an AA or AS from VCC will be accepted As a junior at Webster without the requirement to take a TOEFL examination.




