

# Welcome to the steps for logging in and setting up your CITI account

## **CITI** is the Collaborative Institutional Training

**Initiative**. It is a web-based training program for university personnel and students in many areas of research related to ethical decision-making and compliance, which provides certification that typically is recognized as current for three years.

Register: If you have never registered before (you do not have a CITI Program username) please go to <a href="https://www.citiprogram.org">https://www.citiprogram.org</a> and register an account in the system by clicking on "Register" buttonunder "Create

an account" from the homepage. After typing and selecting your institution from the dynamic drop down list, follow the prompts to create your account. If you already have a CITI

Program username, please log into your account, go to
Main Menu, and follow the "Click here to affiliate with
another institution" link. Type and locate your institution via
the dynamic drop down list and add "Valencia College."

## **Quick steps**





To register at CITI, please follow the 7 steps:


**Step (1):** Type in the organization you are affiliated with in the search bar- "Valencia College". After selecting Valencia College, a prompt will appear below asking you to check the boxes and agree to the Terms of Service and affirm the affiliation with Valencia College.




**Step (2):** Provide the personal information (First Name, Last Name, email address). Please use your Valencia e-mail address.




**Step (3):** Create a username, password and select security questions.



Step (4): Complete the prompts on step 4.




CITI is independent from Valencia College. When you are asked on this screen if you want to be contacted, that question is from CITI.




**Step (5):** Continue to select the answers, based on the questions and the preferences provided. Please note that this award of credits is not done through Valencia and it is not related to your courses at the College. It is for outside certification.


If you are completing CITI modules for a Valencia College course, please ask your faculty member about any course credit options and if available, how and when they will want you to submit proof of completion. Typically, the courses ask you to complete them with correct responses at 75% or higher and you can retake them as many times as you would like.




**Step (6):** Fill out the sections in the prompt. Please make sure to fill in the required fields marked with an asterisk \*

- For *Institutional Email address:* be sure to include your Valencia College email address.
- For *Employee number*: please enter your VID without the "V" (the VID consists of 8 digits).
- For Students: please enter your VID as the "employee number" (the VID consists of 8 digits).
- > For *Department*:
  - Faculty and staff members: please note the academic department, division, or office you work within.
  - Students: please note the department that your course is offered in, for example, "Psychology" would be "Social Science". The College catalog may help you: https://catalog.valenciacollege.edu/coursedescriptions/courseprefixesheadings/
  - For Role in Research:
    - Professors: Please select "faculty" as your role in research (as in the first screenshot below).
    - Students: Please select "student researcher- undergraduate" (as in the second screenshot below).





- **Step (7):** The last step involves Curriculum selection. Select the courses by answering the questions under Select Curriculum- CITI Curriculum Selection. Please note that your institution has prescribed your course curriculum.
- > Students: Select the courses that your faculty member has requested and/ or that you would like to take. You can update these selections at any time. If you are uncertain about the courses you need to take, please ask your instructor.




